Sub:- Notice Inviting E-Tender (E-NIT) against **TS-01/2026-27** for Painting of transformer and equipment CT, PT, CB, Isolator etc. and other associate work at 220KV Seoni, 132KV Seoni and 132KV Nainpur Substation under Testing Division SEONI.

E-tender is invited for **Painting of transformer and equipment CT, PT, CB, Isolator etc. and other associate work at 220KV S/s Seoni, 132KV S/s Seoni and 132KV S/s Nainpur under Testing Division Seoni.** The tender specification is as under: -

TS-01/2026-27:	Painting of transformers and equipment, CT, PT, CB, Isolator etc. and other associate work at 220KV Seoni, 132KV Seoni and 132KV Nainpur Substation under Testing Division Seoni.
Documents :	Rs. 590*/- for one set of tender.

1. QUALIFYING REQUIREMENT OF THE BIDDER: -

- a. **Experience & Performance of the Bidder:** - The bidder should have successful experience of 50% value of similar work completed including piecemeal works in the past at the same or higher or just below voltage level for the proposed Painting work in any EHV Substation of reputed organization preferably in Govt. & Public Sector/ Autonomous body and have adequate tools & plants, financial & technical resources, and infrastructure backed with qualified agencies to execute the work within the specified time frame. (Bidder is required to submit the list of clients as above along with a satisfactory performance certificate from one of such).

Or

The bidder may be Degree / Diploma Engineers having minimum 5 years successful experience of similar works executed under him while in service in Govt./Quasi Govt./P.S.U. organization.

Or

Bidders having no past experience in their own name may also participate subject to condition that they will engage an engineer having educational qualification of Degree in Engineering in their respective branch with at least 2 years experience or Diploma in Engineering in the

respective branch with 5 years experience in the respective field of MPSEB /MPPTCL or Govt./Public undertaking/Reputed Limited Co.

- b. **'A-Class' Electrical Contractor License-** The firm/individual bidder should have 'A-Class' Electrical License issued by Chief Electrical Inspector and Chief Engineer (Electrical safety) of Govt. of MP, Bhopal [In short CEIG & CE (ES)] in his own name/ in the name of firm.
- c. **EPF A/c Number** - The individual bidder/ firm should have an EPF A/c Number in his own name/ in the name of the firm issued by Regional Provident Fund Commissioner.
- d. **Copy of Registration of ESIC** :- The individual bidder/ firm should have submit an ESIC registration Number in his own name/ in the name of the firm
- e. **GST Registration Certificate** - The individual bidder/ firm should possess a valid "GST Registration Certificate" in his own name/ in the name of firm.
- f. **Income Tax Returns & PAN card** - Copies of Income Tax Returns for last three years and PAN card in the name of Firm/ Contractor shall have to be submitted along with bid.
- g. **Labour License** - The firm/ individual bidder should possess a valid Labour License issued by Labour Department, GoMP to engage labour in the business of man power supply as per "Contract Labour (Regulation & Abolition) Act-1970". In case the aforesaid license is not available an undertaking shall have to be given regarding making the same available within 15 days' time on receipt of Work Order.
- h. It is essential that "A" class Electrical Contractor's License, Labour License, GST Registration Certificate & EPF Registration should bear exactly the same name of the applicant as indicated by him in Schedule-I. The order shall be issued in the name of individual/ Firm as per the name indicated in "A" class Electrical Contractor's License issued by Chief Electrical Inspector and Chief Engineer (Electrical safety) of Govt. of MP, Bhopal. In case of any miss-match in the name printed on aforesaid documents offer shall be rejected.
- i. **Qualification & Experience (In case of the Firms or individual bidder)** - The bidder should have adequate tools & plants, financial & technical resources, and infrastructure backed with qualified agencies to execute the work within the specified time frame. The bidder should have "A" class contractor's certificate issued by Govt. of M.P., E.P.F. No. and adequate experience of painting work in EHV Substations which should include one or more of the following:
 - j. The bidder should have successful experience of 50% value of similar work completed including piecemeal works in the past at the same or higher or just below voltage level for the proposed erection work in any EHV Substation.
- k. **Details of ongoing works-** Bidders who have executed or are presently executing similar types of jobs in past shall have to give details of ongoing works in Schedule- 2.
- l. **Performance of the Bidder** - For bidders having executed work in MPPTCL, "Performance Report" in MPPTCL of the Bidder shall be observed

& it should be "**Satisfactory**" in respect of all earlier and running contracts. (The bidder shall have to submit Work Completion Certificate). In case of new bidder (not executed any work in MPPTCL) performance is not required.

1.1. Submission of additional documents - Bidders may please note that the evaluation shall be carried out based on documents, schedules, certificates etc. submitted by the bidders along with their bid and in case of incomplete documentation, their bid may run the risk of rejection as preferably, no additional documents shall be sought by MPPTCL and no additional documents after submission of bid will be accepted from the bidders. However, one chance may be given to bidders for submission of necessary information/ documents/ clarification within a reasonable time indicated in request letter of MPPTCL subject to maximum of 07 working days from the date of request made. However, such request for submission of additional Information/ documents/ clarification shall be made by MPPTCL within 15 working days from date of opening of techno-commercial bids of respective tender. Thereafter, based on available documents/ information, proposal shall be finalized i.e. the bids of such bidders who failed to submit requisite documents within prescribed time mentioned in request letter of MPPTCL shall be rejected on account of incomplete documents. Also, MPPTCL will not make any further correspondence in above reference. Therefore, while submitting the bid, Bidders are requested to ascertain thoroughly and verify that the documents, schedules, certificates etc. being submitted are correct and in line with requirements stipulated in the tender documents. In case of incomplete/ incorrect submission of documents, schedules, certificates etc. or in-case are not fulfilling requirements/ qualification criteria etc., bids may run risk of rejection for which bidders shall be solely responsible.

1.2. ELIGIBLE BIDDER: -Tenderer/ bidder should not be the officer/ employee or relative of MPPTCL. As per Section-2 [TT] of the Company Act 2013, the definition of relative is as follows: -

A person shall be deemed to be a relative of another if: -

- [a] They are a member of a Hindu undivided family, or
- [b] They are husband and wife, or
- [c] The one is related to the other in the manner indicated below: -

1.2. In compliance to the above condition no. 1.2, an Affidavit should invariably be submitted by the tenderer/bidder along with their bids. (Format of Affidavit to be submitted is given in Annexure-II for ready reference).

2. PURCHASE/ DOWNLOADING OF TENDER:

- a. Cost of the Tender Document is **Rs. 590.00** [including GST]. The tender document is also available on MPPTCL's web site in a downloadable format for observation. No fee for downloading of bid documents is required, however cost of Tender document mentioned above shall be compulsorily deposited by the firm/ Bidder, while submitting the bid online. It is obligatory for the bidders to purchase tender from main portal <http://www.mptenders.gov.in> by making online payment for prescribed non-refundable tender document cost using online Payment Gateway Services integrated in to the e-Procurement System Services & in addition gateway charges shall also be borne by the bidder. **No exemption is allowed to any category of bidder from submission of "Tender Cost" otherwise the bid shall be liable for rejection.** Tender Cost is not refundable except only in case the tender is dropped without opening. In the latter case the tender cost shall be refunded after deduction of necessary portal charges. Manual purchase of tender is not allowed.

 - c. Since the online bidders are required to sign their bids online using Class III- Digital Certificates only, hence they are advised to obtain the same at the earliest. 3. Bidders intending to participate in the Tender are required to get themselves trained on the e-Procurement System.
 4. The EMD of respective amount in favour of **Regional Account Officer, MPPTCL, Jabalpur**, along with Hard Copy of tender & supporting documents duly filled in, except Schedule of Prices, shall be submitted in the office of undersigned as per online key date.
 5. The corrigendum or addendum to the bidding documents, if any as well as any change in due date(s) of opening of tender will be published on the website <http://www.mptenders.gov.in> & also Company's website <http://www.mptransco@nic.in> but will not be published in newspapers. Hence participant bidders are advised to regularly visit the websites until the bid opening. The Company shall not be responsible in any way for any ignorance of the bidders about the corrigendum or addendum or change in the due date (s).

- 6. Submission of Documents** - Physical Hard copy of the Tender need not to submit. Manual purchase and submission of the tender are not allowed.

Tender complete with all prescribed particulars, schedules and tender forms duly fill-in, upload in MP e-Tender portal on or before the due date and within specified timings as per the tender notice.
