The Ministry of Road Transport and Highways, Government of India is engaged in the development of National Highways and as part of this endeavour, it has been decided to undertake the development, maintenance and management of the below mentioned National Highway sections in the State of Maharashtra. The Regional Office (MoRTH), Mumbai is Ministry's Office in Mumbai and has been entrusted with the task of appointment of Consultancy Services Authority Engineer for supervision of Rehabilitation and upgradation of Trimbak - Mokhada - Jawhar - Manor - Palghar section of NH-160A from km 101.100 to km 188.405 to two lane with paved shoulder configuration (length = 87.305) and km 188.405 to km 208.135 to four lane with paved shoulder configuration (length = 19.730 km) in the state of Maharashtra on EPC mode (Total Length - 107.035 km).
