The Ministry of Road Transport and Highways, Government of India is engaged in the development of National Highways and as part of this endeavour, it has been decided to undertake the development, maintenance and management of the below mentioned National Highway sections in the State of Maharashtra. The Regional Office (MoRTH), Mumbai is Ministry's Office in Mumbai and has been entrusted with the task of appointment of Consultancy Services Authority Engineer for supervision of Rehabilitation and upgradation of the Talegaon - Warud - Gonapur (MP Border) section of NH-347A from design km 14/300 to km 19/480, km 24/160 to km 24/850, km 31/060 to km 47/000 and km 48/000 to km 60/820 to two lane with paved shoulder configuration in the state of Maharashtra on EPC mode (Total Length - 34.24 km).
