Sub: RFP for procurement of Consultancy Services Authority Engineer for supervision of Upgradation to 4 lane with paved shoulder configuration of the Yedshi - Jawale section from design km 20/470 to 24/350, Bargaon Kale to Murud Akola section from km 61/875 to 72/975 and Harangal ROB (km 84/320 to km 85/380) of NH-63 in the State of Maharashtra on EPC mode (Total Length 16.040 Km.).

The Ministry of Road Transport and Highways, Government of India is engaged in the development of National Highways and as part of this endeavour, it has been decided to undertake the development, maintenance and management of the below mentioned National Highway sections in the State of Maharashtra. The Regional Office (MoRTH), Mumbai is Ministry's Office in Mumbai and has been entrusted with the task of appointment of Consultancy Services Authority Engineer for supervision of Upgradation to 4 lane with paved shoulder configuration of the Yedshi - Jawale section from design km 20/470 to 24/350, Bargaon Kale to Murud Akola section from km 61/875 to 72/975 and Harangal ROB (km 84/320 to km 85/380) of NH-63 in the State of Maharashtra on EPC mode (Total Length 16.040 Km.). The Regional Office, Mumbai invites separate package-wise proposals from eligible consultants for engaging Independent Engineer (AE) on the basis of International Competitive Bidding for the following contract packages in the State of Maharashtra under NH(O) program through e-tendering portal of Government of India.
