

3. (a) Form Fee ( Cost of RFQ & RFP Document) which is Rs. 10,000/- (Rs. Ten Thousand only) for the work specified above shall be paid only through NTRP (Non-Tax Received Portal) portal (<http://bharatkosh.gov.in/>) to PAO (NH), New Delhi and Drawing & Disbursing Officer (DDO) will be "Section Officer (W&A). Bid Security shall be submitted in the form of BG only. Original Document of Bid Security will have to be deposited in the office of Executive Engineer, NH Division, Lakhisarai at Munger / Superintending Engineer, NH Circle, Bhagalpur / Chief Engineer, N.H. Wing (South) Patna / R.O. MORT&H, Patna on or before 13:00 HRS on 24.05.2026, failing which the RFQ & RFP Document will be rejected.
- (b) Bid Security money shall be in favour of Executive Engineer, NH Division, Lakhisarai at Munger in the form of a Bank Guarantee issued by Nationalized Bank or a Scheduled Bank in India having a net worth of at least Rs. 1000 Crore in the format at Appendix -II (The Bank Guarantee) and having a validity period of not less than 180 (One Hundred Eighty) days from the bid due date.
4. For participating in the above E-RFQ & RFP process, the contractors shall have to obtain user ID, password and digital signature may be issued to them. This will enable them to access the website [On CPP Portal of NIC ([eprocure.gov.in](http://eprocure.gov.in))] and download/ participate in E-EPC tender.
5. The blank RFQ & RFP documents can be downloaded from our on website [On CPP Portal of NIC ([eprocure.gov.in](http://eprocure.gov.in))] where electronic RFQ & RFP form is provided.
6. Bidders/Contractors can access RFP documents on the website, fill them and submit the completed RFP document into Electronic RFP on the website itself. Bidders/Contractors shall attach scanned copies (PDF, JPG) of all the required RFP papers, i.e. Bidding Documents & the certificates as required in Eligibility criteria.
7. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates. Bidders/Contractors shall also submit hard copy in two sets of uploaded document to the Office of Executive Engineer, NH Division, Lakhisarai at Munger / Superintending Engineer, NH Circle, Bhagalpur / Chief Engineer, N.H. Wing (South) Patna / R.O. MORT&H, Patna
8. The RFP can also be viewed on Ministry's web site: [www.morth.nic.in](http://www.morth.nic.in).
9. The bidder is requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of Download ability/visibility of the scanned & uploaded file by them.
10. The bidder is directed to zip their files using Win Zip or Win RAR software only. Other formats of zipping will not be accepted and will be rejected.
11. The bidder must use MS Office-2007 or lower version.
12. File size should be less than 5MB and should be in MS Word, Ms Excel, PDF and JPEG formats.



13. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
14. Corrigendum / Addendum / Corrections, if any will be published on the website. The completed RFQ & RFP document should be submitted at the above address on or before 17.00 HRS on 24.05.2026. Technical Bid will be evaluated first. The Financial Bid of the successful bidders only will be opened. After the evaluation of Financial Bid the agreement for execution of works, if any, would be executed between the successful bidder & the respective Authority. However, the Authority reserves the right to reject bid of any applicant without assigning any reason.
15. Bitumen/Emulsion purchased by the Contractor from "Indian Public Sector Oil Company" only will be used in the work.
16. Any Contractor registered with the Central Government / any State Government or any PSU or an agency of International or National repute may participate in the RFQ/RFP but registration with the Road Construction Department Bihar will be essential after issue of L.O.A. and before executing the agreement.
17. The undersign reserves the right to extend/cancel the tender (RFQ & RFP) at any stage without assigning any reason thereof.
19. For Bituminous work, Batch Mix Type Hot Mix plant is necessary.
