The GST of Rs.1,800/- (Rs. Eighteen HundredOnly) applicable on the sale of tender document shall be submitted in

the form of Demand Draft favouring “**Regional Pay & Accounts Officer (NH), MORTH, Bengaluru**” payable at Bengaluru.
