Tender documents, Scanned copy of Contractor Registration Certificate, Registered Contractors of composite category in appropriate class CPWD, State PWD, MES, Railway, BRO and BSNL registered in appropriate class Experience Certificate of previous work done of successfully completed in same nature of work, Pan Card, Detail of turnover of last 3 years and Income Tax Return for the last years, valid Goods & Service Tax Identification Number (GSTIN) or copy of applied for Earnest Money Fee will have to upload online after self-certification of all requisites documents before critical date of submission. The enlistment of the contractor should be valid on the last date of submission of Tender.

3. The Bid document consisting of drawings, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract can be seen and downloaded from website.


