RFP for Construction of 4-lane Greenfield corridor Ghazipur-Zamania-Saiyad Raja of NH-24 (Old NH-97) with extension up to Varanasi-Ranchi-Kolkata corridor from Km 0+000 to Km 51+850 (Total length: 51.850 km) in the state of Uttar Pradesh on HAM mode (Package-II).

The Government of India had entrusted to the Authority for Construction of 4-lane Greenfield corridor Ghazipur-Zamania-Saiyad Raja of NH-24 (Old NH-97) with extension up to Varanasi-Ranchi-Kolkata corridor from Km 0+000 to Km 51+850 (Total length: 51.850 km) in the state of Uttar Pradesh on HAM mode (Package-II) (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. physically in original by the Lowest Bidder before issuance of Letter of Award (LOA) by the Authority. However, while submitting Bid Security via Account Payee Demand Draft, Fixed Deposit Receipt or Banker's cheque, it is to be ensured by the Bidder that Account Payee demand draft or Banker's cheque are submitted physically latest within 5-working days of the Bid Due Date (upto 11:00 hours) Please note that the Authority reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
