The Ministry of Road Transport & Highways through National Highways Authority of India is engaged in the development of National Highways and as part of this endeavour, it has been decided to undertake balance work of 2-Lane with paved shoulder of Najibabad Kotdwar section of NH-119 from design Ch. 122.200 to Km. 137.760 (Existing Ch. 138.635) in the state of Uttar Pradesh through an Engineering, Procurement and Construction (EPC) Contract.

However, while submitting Bid Security via Account Payee demand draft or Fixed Deposit Receipt or Banker's Cheque, it is to be ensured by the Bidder that Account Payee demand draft or Fixed Deposit Receipt or Banker's Cheque are submitted physically latest within 5 working days of the Bid Due Date (upto 11:00 hours).
