The Ministry of Road Transport & Highways through National Highways Authority of India is engaged in the development of National Highways and as part of this endeavour, it has been decided to undertake Widening and Improvement of existing carriageway to 4 lanes of Kaliabor - Numaligarh section (from Km. 315+315 to Km. 400+990) of NH-37 (New NH-715) including Implementation of Wildlife-friendly Measures Proposed on Kaziranga National Park (KNP) Stretch in the state of Assam under NH(O) through an Engineering, Procurement and Construction (EPC) Contract.

However, while submitting Bid

Security via Account Payee demand draft, or Fixed Deposit Receipt or Banker's Cheque, it is to be ensured by the Bidder that Account Payee demand draft, or Fixed Deposit Receipt or Banker's Cheque are submitted physically latest within 5 working days of the Bid Due Date (upto 11:00 hours). Please note that the National Highways Authority of India reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
