**Invitation for Bids (IFB)**

Construction of Viaduct between km 71+075 to km 71+225 in Parwanoo-Solan section of NH-05 on EPC mode in the state of Himachal Pradesh.

**(International Competitive Bidding)**

The National Highways Authority of India, hereinafter called “*The Employer*” hereby invites bids (Technical and Financial) through e-tendering from eligible bidders for “*Construction of Viaduct between km 71+075 to km 71+225 in Parwanoo-Solan section of NH-05 on EPC mode in the state of Himachal Pradesh*” as detailed in the Table below:

1. Eligibility of bidders will be assessed on post qualification basis. The Authority has adopted single stage two-part system (referred to as the “*Bidding Process*”) for selection of the Bidder for award of the Project. Under this process, the bid shall be invited under two parts. Eligibility and qualification of the Bidder will be first examined based on the details submitted under first part (Technical Bid) with respect to eligibility and qualifications criteria prescribed in the Bidding Document. (The “*Bidder*”, which expression shall, unless repugnant to the context, include the members of the Joint Venture). The Financial Bid under the second part shall be opened of only those Bidders whose Technical Bids are responsive to eligibility and qualifications requirements as per the Bidding Document.
2. Bidders have to pay a sum of **Rs. 50,000/- (Rupees Fifty Thousand only)** towards payment of cost of Bid Documents to “*National Highways Authority of India*” in Authority’s designated bank account and also upload online payment receipt of the same. 3. It is mandatory for all applicants to have Class-III Digital Signature Certificate (in the name of person who will sign the application) (with both Signing and Encryption Certificate) from any of the licensed certifying agency ("CAs") [Bidders can see the list of licensed CAs from the link [www.cca.gov.in](http://www.cca.gov.in)] to participate in e-tendering of the Authority.
4. Authorized Signatory holding Power of Attorney or person executing/delegating such Power of Attorney shall only be the Digital Signatory. In other cases, the BID shall be considered **non-responsive**.
5. The complete BID document can be viewed /downloaded from official portal of e-procurement portal of NHA <https://etenders.gov.in> from **03.06.2026 to 02.07.2026 (upto 1500 Hrs. IST)**. Bid must be submitted online at <http://etenders.gov.in> portal on or before **02.07.2026 (up to 1500 hours IST)**.
6. All the documents shall be submitted physically in original by the Lowest Bidder before issuance of LOA by the Authority except the Financial Bid comprising Priced BOQ along with total Bid Price which shall be exclusive of GST which is required to be filled online only in the prescribed format provided on e-tendering website. Bidders (including individual or any of its Joint Venture Members) failing to submit the original documents required as per above shall be unconditionally debarred from bidding in NHA projects for a period of 5 years. Also, the scan copy of all the documents are required to be submitted online on E- procurement portal of NHA. The documents shall be prepared and scanned in different files (in PDF or JPEG format such that file size is not more than 30 MB) and uploaded during the on-line submission of BID.

The bid must be accompanied by Bid Security of the amount specified in the above payable at RO Shimla and drawn in favour of National Highways Authority of India. Bid Security will have to be in any one of the forms as specified in Clause 17 of ITB (Instructions to Bidders).
7. The Bid must be delivered to **Col. Ajay Bargoti, General Manager (Tech.), RO-NHA Shimla**, physically in original by the Bidder after declaration of

8. The original documents shall be placed in an envelope, which shall be sealed. The envelope shall clearly bear the identification ***“BID for construction of Viaduct between km 71+075 to km 71+225 in Parwanoo-Solan section of NH-05 on EPC mode in the state of Himachal Pradesh”*** and shall clearly indicate the name and address of the Bidder.
9. Bids received online shall be opened on **03.07.2026 (at 1500 hours IST)**. Bid through any other mode shall not be entertained. Please note that the National Highways Authority of India reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
10. **The Bidder or its representative is invited to attend a pre-bid meeting which will take place at RO-Shimla, NHAI on 20.06.2026 at 1100 hrs.**
11. The Financial Bid of bidders whose Technical bids have been determined responsive and who meets the eligibility and qualification criteria including the required bid capacity will be opened on the date to be intimated later.
