With reference to the above Fee Plaza, e-quotations are invited on e-portal of NHA (<http://etenders.gov.in>) for collection of user fee for a period of 3 months or till appointment of new agency by NHA, whichever is earlier. *The Authority reserves the right to take over the fee plaza at any point of time after one month (01) of handover of fee plaza, by given seven (07) days prior notice in writing, The annual potential collection at above fee plaza is Rs 127.04 Crore [the proportions of different categories of vehicles are Car/ Jeep/ Van/ LMV-27%; LCV/ LGV/ Mini Bus-15%; Bus/ Truck (two axles)-16%; Three Axle Commercial Vehicle-07%, HCM/EME/Multi Axle Vehicle (MAV) (Four to six axles)-35%; Oversized Vehicles (seven or more axles)-00%]. The requirement of networth is Rs. 12.704 Crore to be increased @10% for each fee plaza of NHA in-hand/ awarded (Ref. Clause-2.1.2 of RFQ dated 01.01.2021). The bid security for this e-quotation is 0.25% of APC subject to minimum of Rs.10,00,000/- and covered under the common bid security submitted by the bidders along with their application for pre-qualification and the conditions given in Clause-2.4 of RFQ dated 01.01.2021 are applicable.*

2. The cost of e-quotation of Rs. 5,000/- will be deducted from the participating bidders from the non-refundable fee submitted by the bidders along with their application for pre-qualification (Ref. Clause-2.3 of RFQ dated 01.01.2021).

3. The e-quotation in the format enclosed at **Appendix-I** shall be submitted by the bidder on e-portal quoting the daily remittance to be paid to the Authority duly visiting the fee plaza location and understanding the traffic, site conditions, facilities available at fee plaza and terms & conditions given in RFQ dated 01.01.2021 and this invitation. The authorized signatory of the bidder as hosted on the website of NHA shall only be the digital signatory of this e-quotation.

(a) Bids determined to be substantially responsive will be checked and corrected by the Authority for any discrepancy as follows:

"The Bids shall be submitted online in the format prescribed at Appendix-I, either % above or % below the APC (Annual Potential Collection) in Indian Rupees duly signed in electronic form by the bidder's authorized signatory.

(b) In the event that two or more Bidders quote the same amount of Annual Remittance, (the "Tie Bidders"), the Authority shall identify the Selected Bidder by draw of lots, which shall be conducted, with prior notice, in the presence of the Tie Bidders who choose to attend.

4. The e-quotations received shall be declared non-responsive and 5% of bid security of 0.25% of APC subject to minimum of Rs.10.00 Lakh shall be forfeited (Ref. Clause-2.4(a) of RFQ dated 01.01.2021) in case of the following:

- (i) e-quotation with conditions; or
- (ii) A different person, other than the authorized signatory of the bidder as hosted on the website of NHAI, submits the e-quotation; or
- (iii) e-quotation submitted by the bidders not having the prescribed net-worth;
- (iv) *e-quotation submitted by the bidder if the bidder or any of its constituent partner(s)/ director(s) is engaged as System Integrator for the same plaza.*

5. The provisions as per Clause-3, 4 & 5 of RFQ dated 01.01.2021 on Fraud & Corrupt Practices, Miscellaneous and Integrity Pact shall be applicable mutatis mutandis for this e-quotation.

6. The successful Bidder shall furnish to the authority Performance Security consisting in the form of a crossed account payee demand draft/pay order/RTGS, amounting to Rs. [•] (an amount equal to 15 days agreed remittance issued by a Scheduled Bank in India, drawn in favour of the Authority and payable at New Delhi within 5 working days from the date of issue of LoA. **In case the existing agency becomes H-1 and is awarded the plaza, the existing agency will have an option to deposit the differential performance security (i.e., performance security as per new award- performance security already deposited for the existing contract) subject to condition that there are no dues/outstanding against the agency as on date of issue of LOA. An undertaking on a non-judicial stamp paper of Rs. 100/- shall be furnished by the agency in this regard and if the undertaking is found to be wrong/misrepresenting or there is outstanding against the agency as on date of LOA, the agency shall be summarily placed in abeyance from the list of pre-qualified bidders for a period of Six (06) months or as deemed appropriate by Authority.** The contract agreement is required to be signed on the same day of submission of performance security and the fee plaza shall be taken over at 08.00 Hrs. of next day of signing of the contract agreement. The remittance to NHAI shall be made on daily basis. If H-1 quotation bidder fails to comply with the above schedule or intimated to the authority for Non-acceptance of LOA for whatever the reasons; **the Authority may, impose Penalty on such Bidder as Damages on account of failure of the Selected Bidder to acknowledge the LOA as per below mechanism (whichever is higher):**

- (i) (H2 Bid Amount – Existing Remittance) per day X 30 days
- (ii) Bid Security.
- (iii) Further, agency may be debarred for minimum 3 months or maximum 01 year as decided by the Member (CO Division).

The draft Contract Agreement (**Appendix-II**) shall be used for entering into the contract agreement for above work subject to modifications required as per this invitation.

In the event that the Highest Bidder withdraws or is not selected for any reason in the first instance (the “first round of bidding”), the Authority may invite all the remaining bidders to revalidate or extend their respective Bid Security, as necessary, and match the Bid of the aforesaid Highest Bidder (the “second round of bidding”). If in the second round of bidding, only one Bidder matches the Highest Bidder, it shall be the Selected Bidder. If two or more Bidders match the said Highest Bidder in the second round of bidding, then the Bidder whose Bid was higher as compared to other Bidder(s) in the first round of bidding shall be the Selected Bidder. For example, if the third and fifth highest Bidders in the first round of bidding offer to match the said Highest Bidder in the second round of bidding, the said third highest Bidder shall be the Selected Bidder.
