GENERAL CONDITION OF THE TENDER

1. The tender shall be opened online on date and time mentioned on CPP portal or on such later date, as may be notified by NIEPMD. If the said date is declared as holiday at a later date, the tender will be opened on the next working day.
2. The tender shall remain open for acceptance for One hundred & twenty (120) days from the date of opening of tenders by National Institute for Multiple Disabilities (NIEPMD). The time limit for acceptance may be extended by NIEPMD at its discretion for such further period, as it may notify.
3. The tender document should be submitted online through NIC e- procurement portal URL: www.eprocure.gov.in
4. The invitation to tender calls for bid proposals in two parts viz., Technical Bid and Price Bid.

Technical Bid shall consist of EMD for the required amount as per the tender documents and technical details which is required to be submitted online

 - (b) Price Bids shall consist of item-wise price details in the given proforma as per the BOQ chart available in the financial bid of the tender document online. **It is mandatory for all bidders to quote for all items mentioned in price bid.**
 - (c) The technical bid and the price bid are to be submitted online only.
 - (d) At the time and date of opening of tender, first technical bids shall be opened through online.
 - (e) The time and date of opening of price bids shall be intimated to the technically qualified bidders through online by CPP portal only.

7. Tender received from firms and individual who are not authorized dealers but only authorized to quote on behalf of the manufacturer or dealer shall not be accepted. Authorized dealers should attach Authorization or Distributorship or Dealership as the case may be certificates from the concerned Manufacturers which should be valid at the time of tender (Computer generated letter heads of the manufacturer and such certificates will not be treated as valid authorization) duly self-attested however, duly attest Photostat copies. Original Certificate may be verified at the time of opening of the tender / quotation, if demanded.
8. Manufacturers should submit copies of their Manufacturing License, Drugs License, CIN (Corporate Identity Number) and other relevant permission / licenses required for such manufacturing, duly self-attested. Original Certificates should be produced at the time of opening, if demanded. All the documents to be scanned and uploaded online while submitting the bids.
- 9. Manufacture shall have valid GMP Certificate.**
10. Manufacturer should have valid manufacturing license issued by the state licensing authority/central licensing approving authority.
11. The manufacture must be ISO/BIS certified.
12. All the copies are to be scanned and uploaded in the tender document online only.
13. All tenderer should quote his / her rates in terms of Indian Rupees exclusive of all taxes and duties. Applicable taxes and duties should be mentioned separately in the column provided in price bid. In case tax amount quoted zero, no tax will be paid. Amount calculated in column "Total amount with tax" will be final figure for calculation. Any change in tax system by the Government will be implemented on submission suitable orders of proof from competent authority.
14. The specification submitted should match with the specification mentioned in the Tender Schedule.
15. If any tenderer violates or fails to fulfill any one of the above-mentioned requirements, his or her tender may be liable to be rejected.
12. Once the rate is accepted by the NIEPMD and communicated to the successful tenderer, the same shall remain valid throughout the life of the agreement as may be executed in due course with the approved tenderer and no further price escalation will be allowed during such validity period which shall normally be a period of 12 months from the date of execution of the agreement and may be extended subject to satisfactory performance and if mutually agreed upon by both the parties. Any reduction in prices in the market during the contract period, the successful agencies should charge the reduced price. However, incase any increase of price during currency of contract should be borne by the vendor.

or decrease the quantity of tendered items as per its requirement. The procured quantity may be ZERO also during the currency of contract, no claim on non-procurement or minimum procurement will be accepted. The Institute will enter in to annual rate contract for supply of tendered items for a period of one year from date of award of contract. The contract may be extendable for 02 (Two) more years' on annual performance review basis and discretion of Director, NIEPMD. However, it is not binding for either side to extend the rate contract beyond one year any party can refuse to extend the contract beyond one year without assigning any reason. Vendor cannot claim for extension on expiry of contract.

14. A successful tenderer will have to supply the medicines within the period of 30 days or fixed by the Department / Authority. If the supply cannot be made within the stipulated period without any intimation, the Department has the right to procure the materials from any other source and the differences in prices, if any, will be realized from the Security deposit of the approved supplier, as mentioned herein, without assigning any reason thereof.
15. The NIEPMD reserves the right to accept or reject any tender without assigning any reason thereof.
16. Payments will be made only after the medicines are received in full and good condition to be certified by the Indenter and after completion of satisfactorily supply. There shall not be any advance payment and no such request shall be entertained.
17. Any attempts of negotiation / campaign, direct or indirect, on the part of a tenderer with the authority to whom he has submitted the Tender or the authority who is competent finally to accept, shall render such Tender liable to be excluded from consideration.
18. Late / delayed tenders shall not be accepted by e-procure portal. Any other / further clarifications in connection with submission of the tender may be made from the purchase department during office hours on all working days.
19. The Estimated cost of the medicines requirement per year is approximately Rs.1.42 Crores However, NIEPMD is not bound to purchase any specific amount of medicine. It's a rate contract; no item may be procured during whole currency of contract. No legal claim for minimum procurement value will be entertained.
