3. Agreement with Bidders selected through e-procurement shall be eventually drawn in PWD Form No. F2 (Modified).
4. The work shall be completed in all respect as given in above table (*mention the time of completion*) from the date of written order to commence the work. The items of work, plan, specification or any information in connection with the work can be seen in the office of the Executive Engineer, National Rural Employment Program, Godda on any working day during office hours before submitting bid.
5. The State Government hereby defined Standard Operating Procedure (SoP) and reporting of the receipt of Tender Fee, Earnest Money Deposit on submission of bids through the E-procurement portal of Government of Jharkhand i.e. <https://jharkhandtenders.gov.in> (as per instruction Engineer in Chief, RDS, Ranchi vide letter no. 907, dated 04.10.2023).
  - 5.1 (a) Tender Fee and EMD will be received through online mode only. Bidders can use internet banking facility for faster processing of tender fee and EMD. Alternatively, bidders can use NEFT/RTGS challan generated for the tender from <https://jharkhandtenders.gov.in>  
(b) Refund will only be issued to the originated bank account used for the payment of Tender Fee and EMD. So, bidders are advised NOT to close Bank Account used for online payment /(NEFT/RTGS) of tender fee and EMD. If the account is closed, then all the responsibility for the same will be yours.  
(c) No Hardcopy/Physical copy is required to be submitted for tender opening/Evaluation. However Department may ask original documents for verification before award of contract.
  - 5.2 Tender not accompanied with required Earnest Money in the prescribed manner shall be rejected outright and will not be evaluated.
  - 5.3 Clauses 5.1 and 5.2 shall not apply to tenderer(s) who are exempted from depositing E.M. but such tenderer (s) must deposit exemption certificate through online mode issued by the competent authority in such to Executive Engineer (Procurement Officer).
6. According to Letter No. 430 Dated 19.11.2020 of Chief Engineer (Monitoring), Water Resources Department, Jharkhand and in compliance to Letter No. 2146 (s) Dated 09.09.2020 issued by Road Construction Department, Jharkhand the rate more than 10% below of the cost of BOQ is acceptable. The additional performance security for the tender rate more than 10% below, it will be (i) from 10% to 20% below rate from the cost of bill of quantity @ 20% additional performance security (ii) More than 20% below rate from the cost of bill of quantity @30% additional performance security will be applicable. Regarding this provision Jharkhand PWD Code is amended by Clause 172(a) after deleting Clause 163(a).
  - 6.1 In case of valid tenders of equal quoted rate, the tender deciding authority will adopt transparent lottery system. This provision has been incorporated as Clause 163(e) of Jharkhand PWD Code.
7. It will be obligatory on the part of the tenderer (s) to keep their offer open for acceptance for a period of 180 days from the date of opening of the tender.
8. Tenderer (s) shall upload scanned copy of his/her/their registration & exemption certificate (if any) in absence of which the tender(s) may not be considered.
9. Scanned copy of GST Registration and Up-to-date GST Return (GSTR 3B), Income Tax Return of Previous 3 Years, Valid Character Certificate, UCAN and Letter of Registration as contractor shall be uploaded by the tenderer or otherwise it may be rejected.
10. Authority reserves the right to reject any or all the tender(s) received without assigning any reasons thereof.
  - 11.1 In the case of successful tenderer (hereinafter called contractor) the amount of E.M. will be transferred towards Initial Security Deposit in such a manner so that the security deposit will form part of 5% of the approval amount of the approved tender & the remaining 5% shall be recoverable from the subsequent bills of the contractor.

12. The Earnest Money of the successful tenderer (hereinafter called the contractor) which accompany the tender will be forfeited in case the tenderer declines to sign the agreement or fails to deposit Security Money within 10 days of being called upon to do so.

1. Those contractors, who are exempted from depositing E.M. will deposit initial security money within 10 days of being called upon to do so. If they fail to do so or decline to sign the agreement within the stipulated period, the requisite sum of money will be forfeited by way of adjustment from any sum to be paid to him by the department for other works, including his security money and in addition he may be Black Listed and subsequently his registration may be cancelled.

14. It is essential for the tenderer(s) to have ownership/deed of hire ship of the following machineries in working condition.

17. Only e-tenders will be accepted.
18. Instructions received from Deputy Commissioner, Godda during construction of scheme will be acceptable.
19. Clauses given in Letter No. - 423 dated - 19.11.2020 of Chief Engineer (Monitoring), Water Resources Department, Jharkhand and in compliance Letter No. - 2146 Dated - 09.09.2020 issued by Road Construction Department, Jharkhand will be applicable.

21. Affidavit that he/she/they has/have not been Debarred or Blacklisted or any litigation with department by any authority.
22. Details of technical persons and current affidavit of technical persons has to be uploaded.
23. Rules regarding labour license will be applicable.
