Office of Registrar, Cooperative Societies, Jharkhand invites quotations from empaneled insurance companies by Ministry of Agriculture and Farmers Welfare Govt. of India, for the implementation of the Brisa Pradhan Mantri Fasal Bima Yojana (B-PMFBY) in 7 clusters consisting of 24 Districts under yield based crop insurance model viz. Standard/Normal PMFBY, Cup and Cap 80:110 Model and Cup and Cap 60:130 model.

All empaneled Insurance Companies are mandated to get enrolled on <https://jharkhandtenders.gov.in> in order to download the tender documents and participate in the subsequent bidding process. Bidders can also obtain the Tender Document and the draft Insurance Contract from the address given below or from the website <https://cooperative.jharkhand.gov.in>. The details of the proposed crop insurance covers, the instructions to bidders, the process of submission of bids and bid evaluation criteria have been set out in the Tender Document. 1. Introduction

The Pradhan Mantri Fasal Bima Yojana (PMFBY) is the flagship crop insurance scheme launched by Govt. of India in 2016 and is being implemented by various state government for past many years in major crop seasons as per the operational guidelines and instructions issued by the MoA&FW, GoI from time to time. All instructions issued by the MoA&FW, GoI will be applicable during the tender period.

PMFBY is a yield based crop insurance scheme. The financial loss of a farmer growing notified crops in notified areas is calculated under PMFBY by comparing Actual Yield of the crop for a season against pre-defined historical Average Yield Index values; whereas under RWBICS; Actual Weather data is compared against pre-defined triggers over an insurance period.

All farmers growing the notified crops in notified areas can insure their crops under the scheme, however the enrollment of farmers under the scheme is voluntary. Farmer's share of premium will be borne by the state govt, the remaining premium will be shared equally between state and central government. Selection of insurance company will be done by state govt, for implementation of scheme through competitive bidding. Selected insurance company is responsible for claim compensation to the affected farmers based on the claim settlement protocol defined in the operational guidelines of the scheme. Apart from state govt., farmers and insurance company, there is a wide and important role of other stakeholders like Banks, CSC, Insurance Intermediaries, District Administration who are liable to perform their roles and duties as defined in operational guidelines and the instructions issued/will be issued in future by MoA&FW, GoI regarding implementation of Revamped PMFBY.

2. Project Profile and Background

Notified Crops

PMFBY will be implemented in all districts with kharif and Rabi crops as mentioned below. These crops are notified for all 24 districts in the state.

Kharif: Aghani Paddy and Bhadaï Maize

Rabi: Wheat, Rapeseed/Mustard, Bengal Gram and Potato

Cluster Approach

The scheme is implemented in cluster approach method. In each cluster a set of districts has been allocated based on risk profiling of districts and keeping the risk of clusters even.

3. Enrolment of Farmers

- a) The scheme is optional for all farmers loanee and Non-Loanee. Existing Loanee farmers will be given a provision to opt-out from the scheme by submitting requisite declaration to concerned bank branches/through portal at-least 7 days prior to the cut-off-date for enrolment of farmers for the respective seasons. Bank shall also maintain proper records of farmer declarations. Whereas non-loanee farmers can submit online and to intermediators with valid documents. Tenant farmers must submit tenant certificate in a prescribed format.
- b) All farmers are entitled to change the crop up to 2 working days before cut-off date of enrolment through respective Bank branches/CSCs and other intermediaries.
- c) Insurance companies must approve/reject all enrolled farmers within the stipulated time period as defined in the 16.4(13) of Revamped Operational Guideline of PMFBY. Insurance Company cannot reject the policy without prior approval of Agriculture & Farmers Welfare Department.
- d) All farmers including sharecroppers and tenant farmers growing the notified crops in the notified areas are eligible for coverage. However, farmers should have insurable interest for the notified/insured crops.
- e) All the Loanee farmers who have been sanctioned Seasonal Agricultural Operations (SAO) loans from Financial Institutions for the Notified Crops/Seasons will be deemed covered automatically unless a declaration for opting-out is given by the farmer in writing to the concerned bank/branch any time during the year but at-least seven days prior to the cutoff date for enrolment of farmers for the respective seasons.
- f) All the Non-Loanee farmers are required to submit online application on PMFBY portal. Necessary documentary evidence of land records prevailing in the State (Records of Right (RoR), Land possession Certificate (LPC) etc.) and/ or applicable contract/ agreement details/ other documents notified/ permitted by State Govt. Non Loanee farmers are also required to submit, aadhar card, a valid mobile number, bank details, declaration by applicant farmer and consent form from tenant in case applicant is a sharecropper farmer in the prescribed format.
- g) Non-Loanee farmers can enroll themselves under the scheme through nearest bank branch, Common Service Centers, authorized and licensed Insurance Intermediaries appointed by concerned Insurance Company or directly through field employees of concerned insurance company or National Crop Insurance Portal (NCIP).
- h) All farmers can change the name of insured crop up to 2 working days before cut-off date for enrolment subject to terms & conditions and provisions mentioned in Operational Guidelines of PMFBY.

4. Period of Contract

The period of Contract between the Bid Inviting Authority and the selected Bidder shall be for Crop year 2026-27 (Kharif and Rabi), Crop year 2027-28 (Kharif and Rabi) and Crop year 2028-29 (Kharif and Rabi)

5. Coverage of Risks

Yield based basic cover is mandatory. Based on the risk assessment, the bid inviting authority has decided to opt for the following additional risk covers under the scheme and District-crops wise list of risks covered along with applicable TY Calculation Method with Normal Sowing and Harvesting dates is given in Annexure-A.

The Add on Coverages are:

- Add-On Cover 1: Preventive/failed Sowing and Preventive Planting/Germination Losses
- Add-On Cover 2: Post Harvest Losses
- Add-On Cover 3: Localized Calamities: Loss/damage to notified insured crops resulting from occurrence of identified localized risks of hailstorm, landslide, inundation, cloud burst and natural fire due to lightening affecting isolated farms in the notified area.

Risk inception date: - The risk under PMFBY will commence from the date of notification of the scheme or date of commencement of season whichever is earlier.

Yield loss damage for localized calamities and post-harvest losses will be assessed on the basis of individual insured farm level and hence lodging of loss information by farmer/designated agencies is essential. In case of widespread localized calamities, the intimations by Individual farmers are not required. Claims will be calculated based on the loss assessment report/ average yield at village level submitted by State Govt. designated agencies.

If localized calamities occurred after conducted Crop Cutting Experiments then the same procedure will be followed for conducting the loss survey and claim assessment will be applicable as in before harvesting period.

General exclusions: Losses arising out of war and nuclear risks, malicious damage and other preventable risks.

Note: All loss assessment and claim settlement process will be as per detailed protocol defined in the relevant sections of Operational Guidelines.

6. Coverage Limit/ Sum Insured Value of Crops

- a) Sum Insured per unit area (Hectare), of each notified crop for each district has been compiled from district wise DLTC approved Scale of Finance 2025-26 (SoF). The Sum Insured for Crop Year 2026-27 will be based on 2025-26 SoF. In subsequent crop years i.e Crop Year 2027-28 (Kharif and Rabi) and Crop Year 2028-29 (Kharif and Rabi) the sum insured for all crops in all districts shall increase by 5% of Crop Year 2026-27 and so on progressively.
- b) List of notified crops along with per hectare Sum Insured value has been given in Annexure-B

7. Notification of Crops and Threshold Yield (TY)

- a) Details about Notified Scheme (PMFBY), Notified Crops, Level of Notified IUs, Crop-wise Sum Insured, Crop-wise Indemnity Level is given in Annexure-B
- b) Year wise historical Average Yield data for each notified crop at Notified IU level for past 10 years is available on NCIP portal in the format provided in Annexure D
- c) Year wise, Crop-wise, IU level historical Coverage for PMFBY 2018-19, 2019-20 and 2024-25 has been given in Annexure-E
- d) List of district wise crop wise Irrigated area 2021-22 has been given in Annexure-F
- e) Cluster wise Distribution of Notified Districts has been given in Annexure-G

- f) State reserves the right to include or exclude crops and /or IUs from the notified list before commencement of respective season subject to such inclusion/exclusion remains <10% of the total insured cropped area/total number of IUs.

8. Calculation of Threshold Yield

Calculation of Threshold yield (TY):

Fixed TY-Threshold Yield (TY), as derived from the best 5 of the immediate last 7 years crop yield data and notified indemnity level, will remain unchanged for entire contract period. The premium rates quoted by insurance companies will remain unchanged for entire contract period.

In B - PMFBY Fixed Threshold Yield is calculated and is used/going to be used for crop year. 2026-27, 2027-28 and 2028-29.

9. Publicity and Awareness

- a) Adequate publicity needs to be given in all the villages of the notified districts/areas. All possible means of electronic and print media, farmer's fairs, exhibitions, SMS, short films, and documentaries shall be utilized to create and disseminate awareness about provisions and benefits of the Scheme among the cultivators and the agencies involved in implementing the Scheme.
- b) Insurance Companies will conduct Publicity and Awareness immediately on receipt of award of work. All the publicity material/ information should necessarily be uploaded on the National Crop Insurance Portal along with coverage/frequency/ duration, dates etc.
- c) A detailed plan of Awareness and Publicity shall be submitted by the Insurance Company along with the acceptance of Notification of Award.
- d) Insurance Companies and state govt will chalk out plan for capacity building of the associated agents, banks etc. for effective implementation of the Scheme and share it with State Government for their inputs and finalize it. Insurance Companies will also organize training workshops/sensitization program for them. Insurance companies will share the output of these activities to State Govt. & GoI periodically.
- e) Insurance company should spend 0.5% of the total gross premium for publicity expenses at the field level and the corresponding details should be submitted to Central Govt. and State Govt./Nodal Department at the end of every season. In case of expenditure in this category is less than 0.5% of Total Gross Premium, the IC shall deposit the difference in Technology Fund within 3 months of cut-off date for enrolment.
- f) Insurance Company will ensure District and Block/Tehsil/Taluka or equivalent level contact centers manned by a regular manpower for day to day interaction and capacity building of farmers and other stakeholders including banks and district administration.
- g) Insurance company will submit list of its district and block level offices along with list of manpower deployed on field at district and blocks at the time of contract.

10. Premium Rates and Subsidy Premium

- a) Farmer's premium will be maximum of 1.5% for rabi season, 2% for Kharif season and 5% for commercial crops. All farmers enrolled under the scheme would be entitled for subsidy on the Actuarial Premium.
- b) In section 12 (3) of the Departmental resolution (No. PMFBY-23/2023/322, dated 16-03-2024) passed by the Dept. of Agriculture, Animal Husbandry & Co-operative, GoJ, farmer's share of actuarial premium rate shall be borne by State Government.
- c) A token farmer Premium of minimum Rs. 1/- should compulsorily be charged from the farmers to facilitate electronic tracking & enrollment reconciliation.

- d) **The evaluation of bid will necessarily be done based on weighted average premium rate quoted for each crop based on coverage area of last corresponding seasons. If new crops are added in subsequent seasons 30% of average area sown during last three corresponding seasons should be used as weights for calculating weighted average premium rates for these crops.**

11. Goods and Services Tax

Premium collected under the Birsa PMFBY scheme is exempted from applicability of Goods and Service Tax until the same is reviewed by the competent authority of Govt. of India.

12. Seasonality Discipline

Seasonality discipline with timelines as approved by SLCCCI for various activities is given in Annexure -K. The applicability of these timelines will be in accordance with the Terms & conditions and provisions contained in the Operational Guidelines of PMFBY.

13. Assessment of Yield Loss

Widespread Calamities (based on season-end yield): The Scheme operates on the basis of 'Area Approach' i.e., Defined Areas for each notified crop for widespread calamities and insurance unit is Gram Panchayat and block.

In order to maintain the transparency and credibility of CCEs as an objective method of yield estimation, the modalities mentioned in the Operational Guidelines of PMFBY shall be followed.

14. Smart Sampling and Two Yield Estimation

For major crops across states, the following method of Rationalization of number of CCEs without impacting the quality of sampling and estimation results will be adopted.

a) Smart Sampling of CCEs: Technology solutions for rationalization of CCEs based on homogeneous selection of sample/experimental pilots based on crop health condition analysed through Remote Sensing Technology and other New Age technological solutions shall be used for rationalization of number of CCEs for specific areas and crops as notified by GOI from time to time.

b) Two Step Yield Estimation: Two-Step yield estimation shall be adopted for specific areas and crops as notified by GOI from time to time in order to further reduce the number of CCEs to be conducted based on defined parameters to assess the crop-health through proxy indicators like weather data, satellite indices, etc.

15. Implementation of YES-TECH

YES-TECH will be implemented in all of the 24 districts of the state. Mentor Institute for Technology Rollout (MITR) is already selected. Technology Implementation partner will be selected simultaneously with the tender cycle 2026-27 to 2028-29. In the districts where YES-TECH is going to be implemented, minimum 30% of the weightage will be given to technology driven yield assessment of the given IU. Further, relevant clauses under Operational Guideline of PMFBY 2023 and YES-TECH manual would be applicable.

Further any clarifications, notifications and circulars etc. issued from time to time by the GOI, MNCFC and Government of Jharkhand shall always be binding on all Implementing Agencies.

16. Assessment of Payable Claims

16.1. Widespread calamities

If 'Actual Yield' (AY) per hectare of insured crop for the insurance unit (calculated on basis of requisite number of CCEs) in insured season, falls short of specified 'Threshold Yield' (TY), all insured farmers growing that crop in the defined area are deemed to have suffered shortfall of similar magnitude in yield. PMFBY seeks to provide coverage against such contingency.

'Claim' shall be calculated at IU level as per the following formula:

$(\text{Threshold Yield} - \text{Actual Yield}) / \text{Threshold Yield} \times \text{Sum Insured}$

Where Threshold Yield (TY) for a crop in a notified insurance unit is the average yield of best 5 years from immediate past seven years of that season multiplied by applicable Indemnity Level for that crop.

17. Claim Liability and Settlement Procedure

Insurance Company shall take appropriate re-insurance support for their portfolio in order to safeguard insured's interest. Insurer will be solely responsible for settlement of all admissible claims to the farmers.

All payable claims under the scheme will be settled in accordance with the corresponding provisions contained in Operational Guidelines of PMFBY.

18. Payment of Service Charges

All payable service charges to Banks, CSC, other Intermediaries under the scheme will be paid in accordance with the corresponding provisions contained in Operational Guidelines of PMFBY and IRDAI regulations on Payment of commission or remuneration or reward to insurance agents and insurance intermediaries.

19. Monitoring and Review of Implementation

Insurance Companies will ensure effective implementation of the scheme as per provisions given in the Operational Guidelines of PMFBY and share the data as desired by State Government from time to time.

20. Grievance Redressal Mechanism

Insurance Companies will ensure robust grievance and dispute redressal mechanism for effective implementation of the scheme as per provisions given in the Operational Guidelines of PMFBY and share the data as desired by State Government from time to time.

21. Roles and Responsibilities of Stakeholders

Roles and responsibilities as defined in the Operational Guidelines of PMFBY for each stakeholder will be applicable. Call center will also be designated to register the grievances and after due docketing same will be forwarded to the concerned stakeholder for timely disposal.

22. Performance Evaluation of Insurance Company

The performance of the empaneled Insurance Companies will be monitored as per the detailed performance evaluation matrix containing key performance indicators with assigned weightage given in the Operational Guidelines of PMFBY.

23. Penal Provision

Selected Insurance Companies are required to follow the seasonality discipline and provision of Operational Guidelines and instructions issued by the State/Central Government from time to time to ensure benefit of the Scheme is reached within stipulated timelines. Non-adherence of the guidelines and cut-off dates will attract penalty as envisaged in the Operational Guidelines.

24. Objections time period

- a) Farmers can raise his written objection to the district level office within 144 hours (6 days) after survey of localized calamity/ Crop Cutting Experiment/ Post Harvesting Loss, similarly Insurance Companies can raise objection on survey of localized calamity/ Crop Cutting Experiment/ Post Harvesting within 96 hours (4 days) after that no objection will be entertained.
- b) On the objection raised by farmers/insurance companies the concerned Deputy Director Agriculture will constitute a committee for the resurvey in above mentioned cases & Committee decision will be final. The committee will submit resurvey report within 3 days.

25. Description of Bidding Process

As part of the Bidding Process, Bidders are required to submit a single Bid consisting of two parts:

- a) The Technical Bid – Bid Application Letter and other Supporting Documents.
- b) The Financial Bid.

The evaluation of bids will be carried out in two stages:

- i. The First stage will involve the evaluation of the responsiveness of the Bid Application Letters submitted by the Bidders. Only those Bidders that have submitted substantially responsive Bid Application Letters will be notified as being Qualified Bidders and will be qualified to have their financial bids opened and evaluated in the second stage.
- ii. The Second Stage will involve the evaluation of Financial Bids of the Qualified Bidders to determine the Successful Bidder for the award of the Insurance Contract.
- iii. The bidder shall comply with the all the terms and conditions of this tender document unconditionally.
- iv. The Bids must be valid for a period of not less than 60 days from the Bid Due Date (excluding the Bid Due Date).
- v. The Bid Inviting Authority will receive Bids pursuant to the Tender Document and all Bids are required to be prepared and submitted in accordance with the terms of this Tender Document, on or before the Bid Due Date.
- vi. Only those Bidders that agree with the terms of the Tender Documents are invited to participate in the Bidding Process. If any Bidder seeks any deviations to the terms of the Tender Documents or includes any conditions in its Bid, such Bidder shall be disqualified. Hence, all Bidders are requested to go through the Tender Documents carefully and submit their Bids in the formats prescribed in the Tender Documents, only if they unconditionally agree with all the terms and conditions as specified in this tender document.
- vii. Important Note: For this purpose, all Bidders are requested to review and fully familiarize themselves with the Tender Document issued by the Bid Inviting Authority. Ignorance of or failure to review the terms of the Tender Documents (including Bid submission formats) will not be accepted as an excuse for any deviations taken or conditions included by any Bidder in its Bid.
- viii. The Bid Inviting Authority may make available additional information to the Bidders to facilitate the Bidders' due diligence in respect of the insurance cover as and when available with the Bid Inviting Authority, including claims data and historical coverage information.
- ix. It will be assumed that the Bidders have undertaken their own independent due diligence and an independent analysis of all the risk factors that will or that are likely to affect the Premium quoted by them. Such risk factors that the Bidders may consider are: the scope of the cover, the number of farmers in the State, the local and geographical conditions, the enrolments and claims in the previous years, the number of localized intimations reported, the profile of calamities, information on estimated crop yield, availability of service providers, the previous claims experience, the average loss cost, the proposed additional coverages and weather parameters and the rights and obligations of the Insurer under the Insurance Contract.
- x. The Bidders will be deemed to have full knowledge of the Cover, the terms and conditions of the Insurance Contract, whether or not they have undertaken any investigations or studies.
- xi. The Successful Bidder will not be permitted to seek a change in the Premium on the basis of the information provided to it as part of the Tender Documents or its failure to undertake its independent investigations or studies or a breach of any of the assumptions taken by it in its Bid, whether after the Bid Due Date or after the execution of the Insurance Contract, except as expressly permitted in this Tender Document or in the Insurance Contract.

- xii. Bidders are required to quote Crop-wise, District-wise, Actuarial Premium Rates for each cluster for providing the Insurance Cover in their Financial Bids.
- xiii. The Premium quoted by the Bidder shall be the rate of premium payable up to 2 decimal points and shall be exclusive of Goods and Service Tax.
- xiv. The Premium quoted, except for variations under variable TY system shall be binding on the Insurer for the entire Term of the Insurance Contract and the Bidders will not be allowed to revise their Financial Bids anytime during the contract period.
- xv. The Bidders must take into account all risks, costs, liabilities, fees and expenses likely to be incurred in relation to the provision of the insurance services for implementation of the scheme.

26. Instructions to Bidders

- a) The Tender Documents consist of the documents listed in the "**Bid Submission Checklist**".
- b) The Bidders agree that the Bid Inviting Authority shall not be responsible for the completeness of the Tender Documents, if the Bidder does not obtain them in the manner prescribed in the Tender Notice.
- c) The Tender Documents must be read as a whole. If any Bidder finds any ambiguity or lack of clarity in the Tender Documents, the Bidder must inform the Bid Inviting Authority at the earliest. The Bid Inviting Authority will then direct the Bidders regarding the interpretation of the Tender Documents. If any discrepancy, ambiguity, or contradiction arises between the terms of the Tender Documents in relation to:
 - The Bidding Process, the provisions of the Tender Document, the terms and conditions of the insurance cover and the implementation of the scheme, shall prevail.
- d) Bidders are expected to review all instructions, forms, terms and specifications in the Tender Documents. Failure to furnish all information required by the Tender Document or submission of a Bid that is not substantially responsive to the Tender Document in every respect will be at the Bidder's risk and may result in rejection of the Bid.
- e) At any time, prior to the deadline for presenting bids, the procuring entity may for any reason, whether on its own initiative or as a result of a request for clarification by a bidder, modify the bidding documents by issuing an addendum in accordance with the provisions below.
- f) In case, any modification is made to the bidding document or any clarification is issued which materially affects the terms contained in the bidding document, the procuring entity shall publish such modification or clarification in the same manner as the publication of the initial bidding document.
- g) In case, a clarification or modification is issued to the bidding document, the procuring entity may, prior to the last date for submission of bids, extend such time limit in order to allow the bidders sufficient time to take into account the clarification or modification, as the case may be, while submitting their bids.

27. Fraud and Corrupt Practices

- a) The Bidder and its officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process. The Bid Inviting Authority shall reject a Bid without being liable in any manner whatsoever to the Bidder, if it determines that the Bidder has, directly or indirectly or through an agent, engaged in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process.
- b) Without prejudice to the rights of the Bid Inviting Authority, if a Bidder is found by the Bid Inviting Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, such Bidder shall not be eligible to participate in any tender or bid process conducted by the State Govt. or

any of the other ministries, departments, state owned enterprises or undertakings of the Government or the Bid Inviting Authority for a period of 5 years from the date that such finding.

For the purpose of clarity, the following terms will have the meanings given to them below:

Corrupt practices mean:

- a) Offering, giving, receiving or soliciting, directly or indirectly, anything of value to influence the actions of any person connected with the Bidding Process. For the avoidance of doubt, offering of employment to, or employing, or engaging in any manner whatsoever, directly or indirectly, any official of the state or the Bid Inviting Authority who is or has been associated in any manner, directly or indirectly, with the Bidding Process or has dealt with matters concerning the Scheme or arising from it at any time prior to the expiry of 1 year from the date such official resigns or retires from or otherwise ceases to be in the service of the State or the Bid Inviting Authority, will be
- b) deemed to constitute influencing the actions of a Person connected with the Bidding Process; or
- c) Engaging in any manner whatsoever, whether during the Bidding Process or before or after the execution of the Insurance Contract, as the case may be, any Person in respect of any matter relating to the scheme, the Bidding Process or the Insurance Contract, who at any time has been or is a legal, financial or technical advisor of the State or the Bid Inviting Authority on any matter concerning scheme.
- d) Fraudulent practice means any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a person to obtain a financial or any other benefit or to avoid an obligation.
- e) Coercive practice means impairing or harming, or threatening to impair or harm, directly or indirectly, any person or the property of the person to influence improperly the actions of a person.

Undesirable practice means:

- a) Establishing contact with any person connected or employed or engaged by the Bid Inviting Authority or its advisors with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Bidding Process; or
- b) Bidder having a Conflict of Interest. A Bidder shall be deemed to have a Conflict of Interest, if:
 - i. Such Bidder or an Affiliate of such Bidder Controls, is Controlled by or is under common Control with any other Bidder or any Affiliate thereof; provided that this disqualification shall not apply if:
 - ii. The person exercising Control is the Govt, a State government, other government company or entity controlled by a government, a bank, pension fund or a financial institution (other than another insurer, whether Indian or foreign); or
 - iii. Any direct or indirect ownership interest in such other Bidder or Affiliate thereof is less than 26%.
 - iv. such Bidder or its Affiliate receives or provides any direct or indirect subsidy, grant, concessional loan, subordinated debt or other funded or non-funded financial assistance from or to any other Bidder or such other Bidder's Affiliate; or
 - v. Such Bidder has the same legal representative for purposes of this Bidding Process as any other Bidder; or
 - vi. Such Bidder or its Affiliate has a relationship with another Bidder or such other Bidder's Affiliate, directly or through common third party or parties, that puts either or both of them in a position to have access to the others' information about, or to influence the Bid of either one or the Bids of each other.
- c) Restrictive practice means forming a cartel or arriving at any understanding or arrangement amongst Bidders with the objective of restricting or manipulating full and fair competition in the Bidding Process.

28. Eligibility of Bidders

Qualification Criteria

1. Only those insurance companies which are registered with IRDAI and empaneled by the Ministry of Agriculture and Farmer's Welfare, Govt. of India for implementation of the scheme shall be eligible to submit a Bid for award of the Contract for implementation of the scheme.

29. Preparation and Submission of Bids

29.1. Requirements and Conditions of Bid Submission

The RFP tender fees of Rs. 10000/-(non-refundable) to be submitted through online mode. Bidders can use internet banking facility for faster processing of tender fee. Alternatively, Bidders can use NEFT/RTGS Challan generated for the tender from jharkhandtenders.gov.in portal.

Proposals received without or with inadequate RFP Application fees shall be rejected.

Tender Fee shall be submitted through online mode only on or before the last date and time of submission of Technical Proposal.

Technical proposal of only those applicants will be accepted and opened whose tender fee is received on or before the date of submission of technical bid.

Bidders should submit their responses as per the procedure specified in the manual. The bidder must ensure that the bid is digitally signed by the Authorized Signatory of the bidding firm and has been duly submitted (frozen) within the submission timelines. The RFP inviting authority will in no case be responsible if the bid is not submitted online within the specified timelines.

All the pages of the Proposal document must be sequentially numbered and must contain the list of contents with page numbers. Any deficiency in the documentation may result in the rejection of the Bidder's Proposal. All the pages of proposal document should have a seal and sign of authorized signatory.

Please Note that Prices should not be indicated in the Technical Proposal.

The response to RFPs must be submitted on the <https://jharkhandtenders.gov.in> by the date and time specified in RFP Schedule for the RFP. Any proposal submitted on the portal after the mentioned deadline will not be accepted and hence shall be automatically rejected. RFP inviting authority shall not be responsible for any delay in the submission of the documents.

Bids submitted after the due date will not be accepted by the e-Tender system and hence will automatically be rejected. The RFP inviting authority shall not be responsible for any delay in the online submission of the proposal.

Bids submitted by telex/telegram/fax/e-mail/post etc. shall not be considered. No correspondence will be entertained on this matter.

29.2. Cost of Bidding

The Bidder shall bear all costs whatsoever associated with the preparation of the Bid, carrying out its independent studies on the implementation of the scheme or verification of data provided by the Bid Inviting Authority. The Bid Inviting Authority shall not be responsible or liable for any costs, regardless of the outcome of the Bidding Process.

29.3. Language of Bid and Correspondence

The Bid prepared by the Bidder and all correspondence and documents related to the Bid exchanged by the Bidder and the Bid Inviting Authority shall be in English.

29.4. Validity of Bids

Each Bid shall remain valid for a period of 60 days from the Bid Due Date (excluding the Bid Due Date). In exceptional circumstances, the Bid Inviting Authority may extend the Bid validity period prior to the expiration of the Bid validity period. The request and the responses shall be made in writing. An extension of the Bid validity period will not entitle a Bidder to modify its Bid.

29.5. Number of Bids

Each Bidder shall only submit one Bid consisting of the Bid Application Letter, the Technical Bid and the Financial Bid. If a Bidder submits more than one Bid, then all such Bids submitted by the Bidder shall be rejected.

Note: The bidder can participate in all clusters identified for Jharkhand state in the same tender and premium has to be entered in the same BoQ. No separate bids has to be submitted for each cluster.

29.6. Bid Submission

The Bidder shall submit the following documents as part of the Bid Application Letter submission:

Technical Bid:

The Technical Bid should be prepared as per order of documents requested below with Table of Content and Page No on front page. The bidders should ensure that all documents are submitted in order.

- a) **Certified copy of latest registration/renewal License issued by IRDAI**
- b) **Proof of empanelment by Government of India under PMFBY**, mentioning the period of empanelment
- c) **Signed and stamped certificate** confirming that the company has not been blacklisted in any state since Kharif 2017 under crop insurance program (A declaration can be submitted on company's letter head with the signature of the institutional head/power of attorney.)
- d) **Office address, phone number of the company** in the state of Jharkhand on official letterhead. The Selected Implementing Agencies (IA) should will open an office in the District Head Quarter with regular land line phone apart from mobile phone. One staff capable to handle the calls should be available in the office. The company is to submit details of the office, officer, phone no. etc before getting the work order. A declaration on company's head need to be submitted.
- e) **Name, designation, seal, email id, phone & mobile number authorized signatory** on official letterhead.
- f) **Declaration** on authorized channel partners/insurance intermediaries/technical partners on company's letterhead and signature of competent authority on the behalf of company.
- g) **Declaration** on appointment of well qualified resources as District Managers and Block Coordinators on company's letterhead signature of competent authority on the behalf of company.
- h) Bid Application letter in prescribed format along with undertaking from the bidder for unconditional acceptance of terms and conditions of the tender document and declaration for not having declared ineligible, insolvent, de-empaneled or expelled to implement the scheme as per Annexure-H.
- i) Plan and arrangements for implementation of the scheme in Jharkhand i.e The action/work plan for the implementation of the B-PMFBY in brief required to be submitted by the bidders in the technical bid.

Financial Bid:

- a) **The Bidder shall calculate the Weighted Average premium Rate (WAP) as per Annexure I. The bidders are required to fill the district wise, crop wise, season wise premium rate as per Annexure I in a suitable excel format and convert the table in pdf form. This pdf file shall be attached along with the financial cover letter Annexure N. The weighted average premium against each cluster calculated as per Annexure I and against each PMFBY model shall be entered in the bid submission format (BoQ as in excel file).**

The online bid should be submitted on or before the time stipulated in Tender notice. The Bidder shall not include any other documents as part of the Financial Bid.

- b) The Bidders are required to quote premium rate in %ge (Numeric) for all clusters in which they are willing to participate, District-wise, Crop Wise for Crop Year 2026-27, Crop Year 2027-28 and Crop Year 2028-29. The bidders should consider cost of implementation expenses, IEC & BCC expenses, Manpower, overheads etc. in the premium rate they have quoted. Bidders need to ensure that they quote for all districts, all crops, in the clusters they are participating. Bid is open for all the clusters; however, it is bidder's discretion to quote for number of clusters. The premium rate quoted remain applicable for Crop Year 2026-27, Crop Year 2027-28 and Crop Year 2028-29 for both kharif and rabi crops. .
- c) **The bidders need to quote for**
 - Model I: Standard/Normal PMFBY,**
 - Model II: 60:130 cup and cap model**
 - Model III: 80:110 cup can cap models****in the same BoQ (excel sheet).**
- d) **The successful bidder for every cluster have to take the model chosen for the entire state. The selection of model for the state is done by the state govt based on its evaluation.**
- e) Premium quoted should be in percentage terms up to two decimal places.
- f) Selection of models would be done at the time of financial opening of the tender. Crop Insurance Model will be selected based on financial viability. The selection of model will be at the discretion of the competent authority/committee and will be intimated to al ICs.

Submission of Bids:

- a) Bidder shall submit their Technical and Financial bids containing all requisite certificates/undertaking and supporting documents online through e-procurement portal of the state [www.https://jharkhandtenders.gov.in/nicgep/app](https://jharkhandtenders.gov.in/nicgep/app) . The documents submitted in this portal must be digitally signed and the documents should meet the specified file format stipulated in the guideline of eProcurement website.
- b) As a legal requirement, Class3 certificate (preferably with token) is required to access the e- procurement portal. Interested bidders shall need to procure both Signing and Encryption certificates. Signing certificate will be used for Logging in and Encryption certificate will be used for Bid submission. Bidders may approach a Certifying Authority in India for obtaining Digital Signature Certificates, details of which can be accessed from the Controller of Certifying Authorities of the Ministry of Electronics and Information Technology, Government of India at www.cca.gov.in
- c) Bids submitted by in person, post, fax, telex, telegram or e-mail shall not be entertained and shall be rejected.
- d) The Bid Inviting Authority shall not be responsible for any delays, loss or non-receipt of Bids.
- e) If there are delays by the State Government in deactivating the bid submission provision on the e-tender portal, and a bidder is able to upload the documents, the same shall be summarily rejected if the upload time in the software and the system is later than the submission time and date specified in tender notice.
- f) The Bid Inviting Authority may, at its discretion, extend the Bid Due Date for all Bidders by issuing an Addendum/Corrigendum, in which case all rights and obligations of the Bid Inviting Authority and the Bidders will thereafter be subject to the Bid Due Date as extended.

Substitution and Withdrawal of Bids:

- a) A Bidder may substitute or withdraw its Bids after submission but prior to specified time on the Bid Due Date, provided that a written notice of the substitution or withdrawal is submitted to the Bid Inviting Authority.
- b) No Bid may be substituted or withdrawn after the specified time on the Bid Due Date.

30. Bid Opening and Evaluation

Opening of Bids:

- a) The Bid Inviting Authority shall open the bids at the date and time indicated in the Data Sheet.
- b) Only authorized representative (s) of the bidder (s) can attend the bid opening
- c) After opening of the Bids by the Bid Inviting Authority, all Bidders whose Bids have been successfully received on the e-procurement portal shall receive a mail notification informing the details such as the Bid has been opened by the official, department and date and time of opening.
- d) Once all the Qualifying Bids have been opened online through e-Tendering procedure, they will be evaluated for responsiveness and to determine whether the Bidders will qualify for the opening of the Financial Bids.
- e) Financial Bids of only the qualified Bidders will be considered for opening and evaluation on the intimated date. The Financial Bids will be evaluated in the presence of the representatives of the qualified bidders that choose to be present. Representatives of Bidders that have failed to qualify the Technical bid will not be permitted to attend the opening and evaluation of the Financial Bids. However, the results of the Financial Bids of all Bidders shall be available on the e-procurement Portal immediately after the completion of opening process.
- f) Bidders are advised that the qualification of Bidders and evaluation of the Bids will be entirely at the discretion of the Bid Inviting Authority. Bidders will be deemed to have understood and agreed that no explanation or justification on any aspect of the Bidding Process or selection will be given.

Evaluation of Bids and Qualification of Bidders:

Technical Bid Evaluation:

The Bid Application Letters will first be evaluated for responsiveness to the Tender Document. If any Bid is found to have below mentioned errors/omission, then such Bid will be deemed to be substantially non-responsive.

- i. Not complete in all respects; or
- ii. Not duly signed by the authorized signatory of the Bidder; or
- iii. Not in the prescribed formats; or
- iv. Contain material deviations or reservations,

For the avoidance of doubt, a "material deviation or reservation" is one that affects in any substantial way, the scope or the terms and conditions of providing the Covers; or limits in any substantial way that is inconsistent with the Tender Documents, the Bid Inviting Authority's rights or the Insurer's obligations under the Insurance Contract; or would affect unfairly the competitive position of other Bidders submitting substantially responsive bids.

- i. Bid Inviting Authority may reject/ seek clarifications the bids in case of incomplete information or non-compliance of operational guidelines as Bid Inviting Authority deems fit.
- ii. The Bid Inviting Authority will evaluate only those Bid Application Letters that are found to be substantially responsive and to determine whether such Bidders satisfy the Eligibility Criteria.
- iii. In order to determine whether the Bidder satisfies the Eligibility Criteria, the Bid Inviting Authority will examine the documentary evidence of the Bidder's eligibility submitted by the Bidder and any additional information which the Bid Inviting Authority receives from the Bidder upon request by the Bid Inviting Authority.
- iv. After completion of the evaluation of the responsiveness of the Bid Application Letters and the eligibility of the Bidders, the Bid Inviting Authority will notify the qualified Bidders of the date, time and place of evaluation of the Financial Bids. Such notice may be issued on the date of opening of the Bids, in which case the Financial Bids may be opened either on the same day or on the next working day.

- v. The Financial Bids of those Bidders who are not declared as Eligible Bidders will not be opened.

Financial Bid Evaluation:

Upon opening of the Financial Bids of the Empaneled Bidders, they will first be evaluated for responsiveness to the Tender Document. If any Bid is found to have below mentioned errors/omission, then such Bid will be deemed to be substantially non-responsive.

- i. Not complete in all respects; or
- ii. Not duly signed by the authorized signatory of the Bidder; or
- iii. Not in the prescribed format; or
- iv. To contain any material deviations or reservations, (a material deviation or reservation shall have the meaning ascribed to it in clauses above).
- v. A substantially non-responsive Financial Bid shall be rejected outright. The Bid Inviting Authority will only evaluate Financial Bids of those Qualified Bidders that have been found to be substantially responsive.
- vi. Once the Financial Bids of the Qualified Bidders have been opened and evaluated for substantial responsiveness:
- vii. The Bid Inviting Authority shall announce the bidders who have qualified the technical bid/bid application letter responsiveness on the day the financial bid is opened. The Bid Inviting Authority shall also notify the unqualified bidders that their financial bid shall not be evaluated further.
- viii. On the day of opening the Financial Bid, the Bid Inviting Authority shall evaluate and tabulate the Crop-wise District-wise Premium rate quoted by each qualified Bidder that has submitted substantially responsive Financial Bid.
- ix. In the course of tabulation, the Bid Inviting Authority shall check for arithmetical errors in each Financial Bid being evaluated. If any arithmetical errors are found, then they shall be rectified as follows:
 - a. If there is a discrepancy between words and figures in any or all of the premiums quoted, then the amount in words shall prevail.
 - b. The Bid Inviting Authority shall calculate the Weighted Average Premium Rate on the basis of rates quoted by the qualified bidders for each cluster and the actual acreage/Sum Insured value during immediate past season. In case a new crop has been chosen for insurance, 25% of the total sown area should be taken for calculation of weighted average premium (WAP). The detailed format and method of calculating WAP is given in Annexure-J
 - c. **The Bid Inviting Authority shall rank the Qualified Bidders based on cluster wise Weighted Average Premium rate as L1, L2, L3 and so on. The L1 is the bidder with the lowest cluster wise quoted Weighted Average Premium rate.**
 - d. **The procedure of selection: "Each insurance company participating in the tender will get allocation of maximum of 3 clusters. After opening of financial bid of all the 7 clusters, In case any company is L1 in more than maximum limit of three clusters then that particular company will get allocation of three clusters which are having lowest weighted average premium rate among all the clusters and remaining clusters where that particular company is L1 will not get any further allocation of clusters and L2 company/companies will be asked for their consent on matching L1 premium rate to allocate cluster's. If L2 company do not agree to match L1 premium rates, then L3 company will be asked for their consent to match L1 premium rates and so on.**

In case any of the "Non L1 company" is not agreeing to match the L1 premium rate, then that cluster shall be allotted to the original company who has proposed lowest weighted premium rate (L1) making an exception to the principle of allocation of maximum of 3 clusters per IC. Initially, cluster allocation will be done on the basis of maximum three

clusters to each company. After that, the clusters which are pending for allocation will be allocated based on above mentioned process in the ascending order of cluster having lowest to highest weighted premium rate for the cluster"

- e. In a scenario where the premium quoted by the lowest bidder does not match the requirement of the Bid Inviting Authority, the Tender Committee shall have the right to call fresh tenders for short duration without disclosing the result of previous bids.
- f. The weighted average premium will be calculated for each cluster for crop year 2026-27, 2027-28 and 2028-29.
- g. Insurance company will be eligible for selection of more than one cluster after finalization of the bid. As per process mentioned in above para-d.
- h. If one and more company quoted same weighted premium rate then L-1 rate will be considered by negotiations as per policy.

Clarification on Bids:

- a) In evaluating the technical Bid, the Bid Inviting Authority may seek clarifications from the Bidders regarding the information in the Bid Application Letter by making a request to the Bidder. The request for clarification and the response shall be in writing. Such response(s) shall be provided by the Bidder to the Bid Inviting Authority within the time specified by the Bid Inviting Authority for this purpose.
- b) If a Bidder does not provide clarifications sought by the Bid Inviting Authority within the prescribed time, the Bid Inviting Authority may elect to reject its Bid. In the event that the Bid Inviting Authority elects not to reject the Bid, the Bid Inviting Authority may proceed to evaluate the Bid by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall not be allowed to subsequently question such interpretation by the Bid Inviting Authority.
- c) The Bid Inviting Authority may not seek any clarifications from the Bidders regarding the information in the Financial Bids. No change in the Premium quoted by the Bidder or any material change to the substance of any Financial Bid shall be sought, offered or permitted.

31. Notification of Award and Execution of Contract

Notification of Award:

- a) Upon selecting the Successful Bidder, the Bid Inviting Authority shall send the proposal to the concerned Administrative Controller for its approval. After obtaining the approval, the Bid Inviting Authority shall issue 2 original copies of a notification of award (the NOA) to the Successful Bidder:
- b) Declaring it as the Successful Bidder;
- c) Accepting its Financial Bid
- d) Requesting it to execute the Insurance Contract and to fulfil the conditions precedent to execution

Within 3 days of receiving the NOA, the Bidder declared as the Successful Bidder shall:

- a) Sign and return 1 original copy of the NOA to the Bid Inviting Authority as acceptance of the terms of the Tender Document and Insurance Contract issued by the Bid Inviting Authority.
- b) If the Bidder that is issued the NOA does not comply with the above conditions; the Bid Inviting Authority may elect to grant such Bidder an extension of time for the completion of such condition(s) or to disqualify the Bidder selected as the Successful Bidder for participation in the re-bid and bids for next 3 Years.

If the Bid Inviting Authority elects to disqualify such Bidder, then the Bid Inviting Authority may:

- a) Ask the L2 bidder to agree to match the premium quoted by L1 bidder and so on.
- b) In case no bidder agrees to match the premium rates quoted by the L1 bidder, The Bid Inviting Authority may cancel the Tender Document and re-invite the bids by giving suitable time to submit the bids.

Execution of the Contract:

- a) The successful bidder will have to sign an agreement with the Office of the Registrar, Cooperative societies, Jharkhand Ranchi.
- b) The Bid Inviting Authority shall, before the date specified in the Bid Schedule for the execution of the Insurance Contract, provide the Successful Bidder with the final execution draft of the Insurance Contract.
- c) The Bid Inviting Authority and the Successful Bidder shall execute the Insurance Contract on the date specified in the Bid Schedule or such other date notified by the Bid Inviting Authority.
- d) The Bid Inviting Authority shall not entertain any request from the Successful Bidder for negotiations of or deviations to the final execution draft of the Insurance Contract provided by the Successful Bidder shall execute the Insurance Contract published by the Bid Inviting Authority.
- e) If the Successful Bidder seeks to materially negotiate or seeks any material deviations from the final execution draft of the Insurance Contract, the Bid Inviting Authority may elect to disqualify the Successful Bidder and revoke the NOA issued to the Successful Bidder. If the Bid Inviting Authority elects to disqualify such Bidder and revoke the NOA, the bidder will be barred from participating in the re-bid and bids for next 3 years in the state.
