OTHER TERMS AND CONDITIONS**

1. The tenders are required to read the tender documents carefully and go through the estimated rates before quoting.
2. Bill of quantity is indicative of nature of work and may not indicate all operation but contractor has to carry out all the operation as per direction of Engineer-in –charge and as per U.P.P.W.D/ PuVVNL/I.S./B.I.S. specification required for proper completion of the work.
3. In BOQ, quantities of individual items are approximate and may vary up to any extent as per the requirement of the site conditions, Overall variation in BOQ amount is limited to 25% as per clause 10 of special condition of tender documents.
4. Before uploading the offer, the tenderer is supposed to inspect the site of work and get acquainted himself regarding site condition/problem and facilities. No compensation shall be admissible to the successful tenderer on account of the site condition.
5. All above work shall be executed as per U.P.P.W.D./U.P.P.C.L./Relevant I.S. Code/B.I.S. Specification or as per direction of E/I. In this regard the Contractor must submit the MTC Certificate of the construction materials being used at site from any recognized Institute/Lab etc as per direction of Engineer Incharge. There will no extra Payment Provided to the contractor for testing of constructional materials.
6. All Electrification material/fittings/and materials of door/windows including fitting etc. shall be got approved from E/I before fixing the same at site of work.
7. Cement shall be arranged by the contractor on is own cost, fresh cement conforming to relevant I.S. of brands such as J.K. BIRLA UTTAM, ACC, AMBUJA or equivalent of major plants shall be used in the work. Contractor shall make proper storage arrangement of cement at site of work to the satisfaction of E/I. cement should always be stored in such a manner to be easily accessible of proper inspection and in a suitable weather tight building or storage shed to protect the cement from dampness.
8. TMT Steel shall be of Fe 415/Fe 500 grade of approved make by E/I.
9. ACE Acrylic distemper and paint etc. shall be of ASIAN/BERGER/J&N Brand of approved quality which shall be got approved before using in the work from the E/I.
10. Flush doors and other fitting Aluminium fitting etc. shall be got approved by E/I flush door shutters shall be 100% waterproof ISI marked.
11. If specifications for any item of work are not covered by any of the documents mentioned in the Contract the same shall be decided and conveyed by the E/I to the contractor.
12. Old bricks, if any shall be recovered from dismantling of brick work in cement/lime mortar as follows :
  - (a) 60% of the total quantity of dismantling brick work shall be treated as received and shall be reused @ Rs. 4200.00 per 1000 in relevant item of old B/W.
  - (b) 25% of the total quantity of dismantling brick work shall be treated as bricks bats and shall be recovered @ Rs. 850.00 per Cum at site and balance shall be treated as malba.
13. Old and dismantled doors and windows if any shall be property of contractor which shall be recovered @ Rs. 200.00 per Sqm. From the contractor.

14. Old unusable steel/scrape if any of R.C.C./RB. Work shall be recovered @ Rs. 24.00 per kg from the contractor.
15. Kachchi shuttering in R.C.C. work is stricity prohibited. R.C.C. is done with Kachchi shuttering, 20% rate of R.C.C. shall be reduced without giving any notice to the contractor.
16. The rates are exclusive of G.S.T. So the quouted Rate by the Contractor is treated as GST extra. GST shall be paid by department as per prevailing law. For reimbursement of GST, The contractor must be registered with G.S.T. Department.
17. Labour cess shall be deducted from the contractor's bills as applicable rates.
18. 2% TDS (GST) Shall be deducted as per prevailing law of the Government from the contractor bill.
19. The rate quoted by firm shall be mentioned in this BOQ for any item is fixed for all floor/height. No extra payment shall be done due to Height for any items in this BOQ Extra items. Variable rate shall not be acceptable and liable to be rejected.
20. The rate mentioned in this BOQ for any item is also include with shuttering, scaffolding etc. No extra payment shall be done shuttering, scaffolding etc. for any items of the BOQ/Extra Items.
