BIDDERS ARE REQUIRED TO QUOTE THEIR RATES FOR CATTLE FEED RAW MATERIALS ITEMS KEEPING IN MIND THE FOLLOWING: -

01. The rates have to be quoted for minimum 50% of required qty. For items other than molasses, failing which rate shall not be considered.
02. Bidders are also required to mention the quantity being offered by them in the BOQ.
03. In case quantity is not mentioned it shall be presumed that 100% quantity has been offered.
04. Bidders have to quote F.O.R. Rates inclusive of all expenses and taxes (GST) in rupees per qtl. individual CFP wise.
05. No expenses and taxes over and above the quoted F.O.R. Rates shall be payable.
06. The bid shall be considered having been submitted based on RCDF registration document attached with tender.
07. Bidders may be asked to supply 10% extra qty. over and above their offered qty. as per clause no. 2.9.16.
08. Only RCDF's prescribed terms and conditions shall be applicable and binding on bidders/registered cattle feed raw material suppliers.
09. Bidders of any item should not have conflict of interest.
10. A copy of registration document is attached for perusal of terms and conditions & quality specifications by bidders.


