TOTAL TENTATIVE QUANTITY OF CATTLE FEED RAW MATERIALS ITEMS IN QTL. REQUIRED BY OUR CATTLE FEED PLANT BIKANER IN TOTO IS GIVEN BELOW. THIS QUANTITY MAY INCRESAE OR DECREASE DEPENDING UPON THE RATES QUOTED IN THE TENDER AND OTHER FACTORS.

BIDDERS ARE REQUIRED TO QUOTE THEIR RATES FOR CATTLE FEED RAW MATERIALS ITEMS KEEPING IN MIND THE FOLLOWING: -

1. The rates have to be quoted for minimum 50% of required qty. For items other than molasses, failing which rate shall not be considered. For molasses rates have to be quoted for 100% of required quantity.
2. Bidders are also required to mention the quantity being offered by them the BOQ.
3. In case quantity is not mentioned it shall be presumed that 100% quantity has been offered.
4. Bidders have to quote F.O.R. Rates inclusive of all expenses and taxes (GST) in rupees per qtl. at CFP Bikaner.
5. No expenses and taxes over and above the quoted F.O.R. Rates shall be payable.
6. The bid shall be considered having been submitted bases on RCDF registration document attached with tender.
7. Bidders may be asked to supply 10% extra qty. over above their offered qty. as per clause no. 2.9.16.
8. Only RCDF's prescribed terms and conditions shall be applicable and binding on bidders/registered cattle feed raw material suppliers.
9. The registered raw material suppliers who wish to participate in the Molasses tender either exclusively for Molasses of combindly along with other items like **DORB, Rice Bran, DOMC, Gwar Korma, Maize, Soyabean Meal & Bypass Fat** etc. have to deposit extra amount of Rs. 3,00,000/- through DD in favour of MD, RCDF Jaipur. **The suppliers would have to apply in writing in advance before the publishing of the fortnightly bid along with the deposition of the additional security amount of Rs. 3,00,000/-.**
10. Bidders of any item should not have conflict of interest.
