Contractors who fulfill the following requirements shall be eligible to apply.

MINIMUM ELIGIBILITY CRITERIA

1. **Work Experience:** The tenders will be qualified only if they have successfully completed the similar nature of works(Maintenance of Fitness equipment) in India during the last Three years **ending previous day of last date of submission of bids.** The Contractors should be experience with Government department such CPWD/ MES/ State PWD/ Railways, PHE, Municipal Corporation, Housing Board, Development Authorities etc.
2. Average annual financial turnover on similar work should be at least 1.5 times of the estimated cost during the immediate last 3 consecutive financial year.
3. The bidders should not have incurred any loss (**profit after tax should be positive**) in more than 2 years during the last 5 years ending 31st March 2025.Balance sheet duly certified and audited by the registered Chartered Accountant.
4. Agency should have solvency of the amount equal to 40% of the estimated cost of the work.(issues by nationalized bank/district authorities)
5. Additional conditions of Eligibility
 - (i) **Joint ventures/ Consortium and Special Purpose Vehicles are not eligible.**
 - (ii) Firms/Contractors who are black listed and/or debarred are not eligible.
6. The intending bidder must read the terms and conditions, Special conditions and General Conditions of Contract etc. carefully. The intending bidder should submit his/their bid only if she/he/they consider himself/themselves eligible and she/he/they is/are in possession of all the documents required.
7. Goods and Service Tax (GST), Labour Cess and any other tax as applicable shall be borne by the contractor himself. The contractor shall quote his rates considering all such taxes.
8. Information and instructions, for bidders posted on website shall form part of bid documents.
9. Bid documents consisting of plans, specifications, schedule of quantities of various types of items of works to be executed and set of terms and conditions of the contract to be complied with and other necessary documentscan be seen and downloaded from website **www.eprocure.gov.in/eprocure/app** free of cost.
10. Bid can be submitted only after
 - (i) Uploading the mandatory scanned documents such as Demand Draft or Pay order or

Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD drawn in favour of **The Regional Director(I/C), SAI-NSRC LUCKNOW receipt of deposition of EMD and** EMD may also be deposited in the account of "Regional Director, SAI, Lucknow" Union Bank of India, Sarojini Nagar Branch, Bank Account No. 537702170100001, IFSC code: UBIN0553778 or through NEFT/RTGS or Demand Draft/Pay Order drawn in favour of "Regional Director, SAI, Lucknow, payable at Lucknow. **The vendor registered under MSME is exempted from submission of EMD.**

(ii) Other documents as specified in the NIT.

- 11. The intending bidder must have valid Class-III Digital signature to submit the bid.**
- 12.** On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 13.** Contractor can upload documents in the form of **JPG** format and **PDF** format.
- 14. Certificate of Financial Turnover:** At the time of submission of bid, contractor may upload Affidavit/Certificate from Chartered Accountant mentioning Financial Turnover of **last 3 (three) years** or and further details if required may be asked from the contractor after opening of Eligibility bids. There is no need to upload entire voluminous balance sheet.
- 15. Eligibility bids** shall be opened first on the due date and time as mentioned above. The date and time of opening of **financial bids** of contractors who qualifies in **the Eligibility Bid** shall be communicated to them at a later date after evaluation of eligibility bids.
- 16.** The department reserves the right to reject any prospective Applications/ bids without assigning any reason thereof and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids/applications satisfying the laid down criteria are received.
- 17.** Bid documents consisting of plans, specifications, the schedule of quantities of various types of work to be done and the set of terms and conditions of contract to be complied with the contractor whose bid may be accepted and other necessary documents can be seen at Sports Authority of India, NSRC Lucknow between hours of 11.00 a.m to 3.00 pm upto **dated** every day except on Saturday, Sunday and public holidays.

The bidder should have successfully completed works as a prime contractor in last five years to government departments/autonomous bodies/PSUs/reputed private organizations with at least one similar work of value not less than the amount equal to 80% of the estimated cost(Rs. 11.48 Lcs) or two similar works, each of value not less than 50% of the estimated cost (Rs. 7.18 Lcs) or three similar works, each of value not less than 40% of the estimated cost (Rs. 5.74Lcs)	The requisite order (s) along with Satisfactory completion certificates issued by relevant authority not less than the rank of Section Officer be enclosed.
4.	The bidders should not have been debarred/blacklisted by any state/central government/PSUs	Enclose blacklisting declaration in the format given in Section IV (I)
5.	The bidder should have a valid GST No. or should have registered under GST for the state for which service is being asked.	Enclose copy of GST Registration certificate for the state for which service is being asked.
6.	Valid Registration Certificate for EPF and ESIC	Enclose copy of Registration certificate
7.	Valid Solvency Certificate	Enclose copy of solvency certificate (at least 50% of the estimated cost) issued from nationalized bank.
8.	The bidder should have a valid office address within 40km radius from the campus	Enclose copy of residential certificate in Lucknow.(rent agreement is not admissible)
