c) One similar completed work costing not less than 80% of Tendered cost.
- Note: - One Completed work of similar nature costing not less than the amount equal to mentioned above of the estimated cost put to tender with some Central Government Department/ State Government Department /Central Autonomous Body/Central Public Sector undertaking.
- ii) Should have an average annual financial turnover of 50% of estimated cost on construction work of similar nature during last three years, ending 31st March 2025 (copy of certificate from C.A. to be submitted).
- iii) Should not have incurred any loss in more than two years during the last five years. Solvency certificate form Banker or District Magistrate to be submitted.
- iv) Information regarding projects in hand, current litigation, orders regarding exclusion, expulsion or black listing, if any should be indicated.


