- (10) No Engineer of gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the state/Central Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the contractor's services submit an affidavit on Rs. 100 stamp paper.
- (11) Any bidder who is having criminal record is not allowed to participate in the bidding process submit an affidavit on Rs. 100 Stamp Paper.
