For and on behalf of Chairman, Shri Mata Vaishno Devi Shrine Board (SMVDSB), e-tenders under two-bid system are invited through the Chief Executive Officer, SMVDSB from reputed professional Companies / Firms dealing in the bulk packing / supply of pasteurized dry fruits for supply of specified “**Pouch Prasad**” to SMVDSB initially for a period of three (03) years as per the following details:

1. **SCOPE OF THE APPROVED VENDOR:**

- (i) The selected bidder shall be required to arrange all the required ingredients of the ‘Pouch Prasad’ in bulk. Besides, setting up and operationalization of complete Plant & Machinery at the built-up space provided by the Board and as per the best industry practices “at no cost to Board”) shall lie in the scope of the approved vendor. The set-up must be adequate to produce the required quantity of ‘Pouch Prasad’ ordered from time to time during the rate validity period.
- (ii) The Shrine Board deserves the right to engage any professional person / agency to adjudge the adequacy of the plant and machinery for the intended purpose and upon communication of any deficiency in this regard, the selected vendor shall be bound to install the deficient equipment/ bridge any other deficiency in a time bound manner. Failing to do so may result in termination of the contract at entire risk and cost of the firm.
- (iii) For setting up of an exclusive packing unit at Katra, the SMVDSB shall allot suitable land parcel / built-up space as per availability and at mutually agreed terms and conditions of such allotment.
- (iv) The Pouch Prasad shall comprise of dry fruits and other items and their quantities as specified in **Annexure- “A”**. All ingredients and the packing material (outer pack and the sub-pack for coin and mouli) shall have to essentially adhere to the minimum quality / specifications defined under **Annexure-“C”**.
- (v) All the ingredients must be pasteurized and processed with 'IR Heating' & 'UV Cooling' in controlled atmosphere to ensure that the dry fruits are crispier, healthier and without any loss of aroma, taste or nutritional value. The dry fruits should be then 'Packed and sealed in specified packing in contamination free environment to avoid any 'post-production contamination.
- (vi) The dry fruits to be supplied should comply and confirm to FSSAI Standards. The selected bidder must have the technical expertise to ensure best hygiene standards for the packed dry fruits. The Board shall be at liberty to go for any number of quality checks from any independent recognized lab at any point of time during the currency of contract with the selected bidder. In case of rejection

of on lot on quality basis, any claims of loss shall not be accepted by the Shrine Board.

- (vii) The selected vendor shall have to comply with the SOPs of Shrine Board issued from time to time to safeguard Board's interests related to quality of ingredients, material and contents of the packing, economy, legality, **sanctity of prasad (including mixing of the prashad actual offered to the Holy Deity** or any other aspect of the agreement between two parties.
- (viii) The contents and design of printing matter of the Prasad Pouch shall be pre-approved by the Shrine Board and may; at short notice, change any number of times during the rate contract period.
- (ix) All costs whatsoever shall be in the scope of the selected firm only i.e. the supplies shall have to be FOR Non-Engineering Store, Banganga, Katra and inclusive of all costs. Not with standing this, any changes in the statutory-taxes frame work shall be adjustable on mutual basis (more details in succeeding paras).
- (x) The Processing Unit shall have to be made operational within 75 days of issuance of Rate Contract. Each PO issued to the selected vendor under the Rate Contract shall have to be executed within 10-15 days of the issuance of PO. The bidding firms must therefore satisfy themselves regarding their capacity to ensure maximum uptime of the plant and machinery, adhere to the prescribed timelines and to maintain adequate inventory of raw materials and finished goods in this regard.
- (xi) After the allotment of suitable built-up area by the Shrine Board, the selected bidder shall be responsible for setting up the Packing Plant (at its own cost) within the prescribed period along with all related fixed assets required for the purpose. All legal compliances / permissions for running the unit will also be the exclusive responsibility of the selected bidder and the role of SMVDSB shall only be limited to providing NOCs as necessitated / approved for obtaining all such permissions. The unit has to be strictly in compliance with all the statutory requirements.
- (xii) **The bidders to specifically note that in respect of provisions of various clauses of this e-NIT relating to allotment of Shrine Board's space / built-up infrastructure, the following shall apply:**
 - (a) **That it shall not be optional but compulsory for the selected bidder to set up the processing and packaging plant in the built-up space provided by the Shrine Board.**
 - (b) **Shrine Board shall provide suitable built-up space to the successful bidder ASAP. The T&C of allotment shall be mutually decided. However, there shall be no license fee or rent in lieu of allotted infrastructure.**
 - (c) **Complete processing and packaging of ingredients including pasteurization shall have to be compulsorily done at the packaging plant set-up by the selected bidder in the allotted infrastructure of Shrine Board only. No part of the processing and packaging process shall be allowed outside of the plant set-up in the Board's infrastructure.**

(xiii) Following shall be the minimum requirement in respect of Automatic Packaging Plant of the Approved Vendor (to be set-up in the Board's premises):

3. **PROCEDURE FOR SUBMISSION OF TENDER:**

The Tenderers are required to submit their Bids(Technical as well as Financial) on e-tendering portal i.e. www.jktenders.gov.in under 2 bids system; as per the details given below:

- (A) **Technical Bid:** The Technical Bid of the bidders must contain the following essential documents to establish their status against the Eligibility and other conditions of this e-NIT:
- I) The Non-Refundable Tender Fee amounting to Rs. 2,500 (rupees Two Thousand Five Hundred Only) has to be deposited in the shape of DD drawn on any Nationalized / Scheduled Bank and payable to FA & CAO, SMVDSB. Similarly, the Earnest Money Deposit (EMD) amounting to Rs. 24 Lakh (rupees Twenty Four Lakhs) can be deposited in the shape of CDR / TDR / FDR of any Nationalized / Scheduled Bank duly pledged to the FA & CAO, SMVDSB.
 - II) Soft copy of Tender Fee (DD) and EMD document (CDR/TDR/FDR) shall be uploaded on the tender portal. - IV) In the case of online transfer of EMD / Tender Fee, the following shall be compulsorily adhered to (without which tenders shall not be considered):
- i) The transfer of Tender Fee and EMD shall be compulsorily done as separate transactions. In case a bidder makes a single transaction of the cumulative amount, his bid shall not be considered.
 - ii) The print-copies of screenshots of both the successful transactions shall have to be submitted in the Purchase Section prior to the specified date of opening of Technical Bids. In addition, the full details of the Bank Account from which the transactions have been made shall have to be written on the body of the Transaction Screenshot.

VI) **Eligibility Conditions (to be supported by valid documents):**

- i) The Bidders shall have to be a legally valid entity, having its registered office in India.
- ii) The Bidding Companies applying should have at least 05 year' experience of running a Dry Fruit Processing & Packing Plant (documentary evidence to be attached).
- iii) In atleast three out of five financial years (ending 31st March, 2025), the bidder must have supplied / packed / sold dry fruits amounting to Rs. 5.00 crore or more (average of any three financial years). For establishing the turnover from dry fruits, the following documentary evidence shall be essentially provided by the bidder:
 - The annual audited balance sheets and profit & loss accounts of the relevant period; authenticated by a Chartered Accountant

with UDIN No. The turnover of sister concerns / subsidiaries / Joint Ventures shall not be considered.

- Copies of purchase bills or sale invoices with e-way bills where applicable.
- If the submitted purchase / sale bills are in foreign currencies, for the purpose of this clause, the invoice value shall be converted into INR equivalent on the basis of mid-market exchange rate applicable on the date of sale (ascertained from reference URL: <https://www.xe.com/currencytables/>).

- (a) Bidder should not have suffered any financial loss in more than one year during the last three years ending 31st March, 2025.
- (b) The Net Worth of bidding firm as on 31.03.2025 should be "Positive".

VII) A copy of the Tender Document with each page duly signed and stamped conforming the acceptance of Terms and Condition mentioned in the e-NIT.

VIII) Declaration Certificate(**Annexure-"D"**).

IX) No Deviation certificate(**Annexure-"E"**).

(B) **Financial Bid / Price Bid:**

- I) Price bid shall be as per BOQ& has to be submitted **online only**(in the format available as **Annexure-"B"**). Submission of Hardcopy of the Financial Bid shall result in rejection of the bid submitted online.
- II) The price bid should be absolute and unconditional.
- III) The price bid shall be opened in respect of the bidders who qualify in the technical stage. Rates are required to be quoted strictly as per prescribed UOM mentioned in the BOQ.

4. **Description of the Material:** The Pouch Prasad shall comprise of dry fruits and other items as per the quantities specified in **Annexure- "A"**. All ingredients (including outer pack and the sub-pack for coin and mouli) shall have to essentially adhere to the minimum quality parameters / specification defined under **Annexure - "C"**.

5. **RATES:**

- A) The rate quoted in the Price Bid must be F.O.R. Non Engineering Store, Banganga, Katra inclusive of GST, levies/discounts & other taxes.
- B) The rate approval order finalized with effect from the date of approval on the basis of this tender shall remain in force for a period of three years. The supplier will have to supply the material against the Purchase Orders issued by this office from time to time during the rate approval period or till the finalization of Fresh Rate Contract whichever is later.
- C) **Escalation of Approved Rate:** During the period of Rate Contract, escalation in the approved rate for pouch parshad shall be allowed at a uniform rate of 3%

per-annual i.e. 3% hike after the end of one year and further 3% hike at the end of two years; both reckoned from the date of issuance of first Purchase Order against the e-NIT.

- D) If the rate of GST gets increased/ decreased or a new tax is introduced or an existing tax is abolished or any change in interpretation or application of any tax occurs in the course of performance/evaluation of contract, which was or will be assessed on the bidder in connection with the performance of the contract, an equitable adjustment of the contract price shall be made to fully take into account any such change by addition to the contract price or deduction the reform as the case may be.

6. **RIGHT RESERVED BY SMVDSB:**

- i. The Board reserves the right to accept/reject or cancel any tender or all tenders in full or part thereof without assigning any reason. In case of any dispute arising out of the Rate Approval Order/ Purchase Order, the decision of Addl. Chief Executive Officer, SMVDSB, Katra shall be final and binding upon both, the supplier as well as the Shrine Board.
- ii. The Shrine Board reserves the right to reject, accept or prefer any tender in part or full at any stage if not in conformity to the specifications, terms & conditions mentioned in the e-NIT. Shrine Board also reserves the right to re-invite the tender at its sole discretion.
- iii. The Shrine Board reserve the right to negotiate the quoted rates, terms and conditions with the lowest tenderer.
- iv. The Competent authority of SMVDB reserves the right to:-
 - a) To cancel/terminate the e-NIT/Purchase order/letter of award(LOA) during the period of its validity without assigning any reason thereof.
 - b) To forfeit the EMD/Security deposit of defaulter supplier.
 - c) Debarring any defaulter supplier from any further dealing with Shrine Board for a period of three years.
 - d) Grant of extension against lapsed POs issued against the Rate Contract (with or without imposing penalty, as deemed right by the Competent Authority).
- v. The competent authority of SMVDSB reserves the right to exempt any of the qualifying criteria, in case the bidder (who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past, subject to meeting the specifications and quality of the product.

7. **BID VALIDITY:**

The offer shall remain valid and open for acceptance for a period of 90 days from the date of opening of tenders. If the tenderer withdraws his tender before the expiry of the said period or makes any modifications in the terms and conditions of the tender, the earnest money/security deposited by the tenderer shall be forfeited without any notice.

8. **PAYMENT:**

No advance payments shall be made. The payment against each PO shall be made after receipt of complete material at Non-Engineering Stores, Banganga, Katra within 20 days from the date of supply of material with proper documents.

9. **DELIVERY PERIOD:**

- i) The successful tenderer shall have to deliver the ordered material within 10 days of issuance of each purchase order issued during the Rate Contract period.

- ii) Notwithstanding the delivery period of 10 days mentioned above, it shall be obligatory for the selected firm to ensure that there is no interruption in the supply line or availability of pouch parshad to the yatri at any point of time during the entire contract period. The firm shall maintain adequate inventory of the ready material to achieve this critical objective. It shall be expected from the successful tenderers(s) that they keep sufficient stock of the approved item(s) for immediate supply of the ordered item(s).
 - iii) The material supplied after the due date may or may not be accepted. In case of acceptance of material after the due date, appropriate penalty may be imposed on the firm at sole discretion of Competent Authority.
10. **INSPECTION/LIFTING BACK OF REJECTED SUPPLIES:**
- i) The material supplied shall be checked / inspected by the quality cell / inspecting team of Shrine Board and if found of inferior quality/defective, the same shall be rejected. The rejected material shall have to be lifted by the supplier at his own risk and cost within a week's time failing which storage charges per day as may be deemed fit to the authority shall be levied.
 - ii) In case the supplies are rejected, same shall be lifted back by the supplier within 15 days from the date of intimation from this office, failing which the penalty @2% of the total value of rejected supplies per day shall be imposed against the supplier for a period of one week which shall be doubled in subsequent weeks and the material shall be in the stores at his own risk & responsibility. Beyond one month the material shall be auctioned and storage charges shall be recovered from the supplier @2% per day. The amount acquired on account of auctioning shall be deposited to SMVDSB Account.
 - iii) In view of sanctity and sensitivity of the end use, the SMVDSB reserves the right to inspect the site of production any number of times and at any time during the validity of the rate contract with the successful bidder, to safeguard against quality related concerns.
11. **Return of Earnest Money Deposit:** The EMD of un-successful Bidder shall be returned within 01 month of the issuance of Letter of Award to the successful Bidder. The EMD of successful Bidder shall be returned within 01 month of the depositing of Security Deposit (SD).
12. **Security Deposit:**
- (i) The successful Bidders shall furnish security deposit equivalent to 5% (five percent) of the total value of the anticipated purchase volume (1 crore pouches), in the form of Bank Guarantee issued by any Nationalized / Scheduled Bank pledged to the Chief Accounts Officer, SMVDSB, Katra within 15 days of issuance of Rate Contract. Failure to do so within the stipulated period shall make the contract liable for cancellation together with forfeiture of the E.M.D.
 - (ii) The validity of Security deposit shall be for the period of agreement plus grace period of 3 months. The security deposit shall be released within 03 months of the satisfactory completion of Contract obligations.
13. **General Information/Important Instructions:**
- (i) The supply of Prasad Pouch shall vary as per influx of Yatra. Accordingly, the actually ordered quantities may vary (even substantially) vis-à-vis the anticipated quantities. The Shrine Board shall not entertain any claims towards real or

perceived losses in this regard.

- (ii) The cost of Tender document shall not be refunded under any circumstances.
- (iii) The Tender offer shall be valid for 90 days from the date of its submission.
- (iv) Tender without requisite fee and not fulfilling all or any of the conditions or submitted incomplete in any respect is liable to be rejected. Conditional Tenders shall not be accepted and shall be outrightly rejected.
- (v) The Tender document shall be duly signed and stamped in respect of acceptance of all terms and conditions.
- (vi) The Bidders shall have to comply with all the statutory provisions as laid down under various Laws/Act/Rules like GST Act, Employees Provident Fund, ESI and other Laws/Acts/Rules in force from time to time, and any such as may be enacted in future during the contract period.
- (vii) The Bidders shall notify in its bid, the details of authorized signatory/key personnel and their contact details for further communications.
- (viii) All the pages of the Tender submitted must be numbered and signed by the authorized signatory.
- (ix) The Bidders shall keep necessary books of accounts and other documents for the purpose of the condition as may be necessary and shall allow inspection of the same by an authorized representative of the SMVDSB Authority and further shall furnish such other information/document as required by the representative.
- (x) Each Bidder shall submit only one Tender. Submission of any additional Tender shall lead to disqualification.
- (xi) The SMVDSB reserves the right to reject any/or all the bids at any stage without assigning any reason thereof.
- (xii) If any information furnished by the Bidder is found incorrect at the later stage, Contract shall be terminated and further penal action such as forfeiture of Security Deposit, debarring for period of three years from participating in SMVDSB's tenders etc., shall be initiated.
- (xiii) Even though any Bidder may satisfy the above requirements, it would be liable for disqualification on grounds of misleading or submitting false information or deliberately suppressing the information in the forms, statement and enclosures required in the Eligibility Criteria document and have record of poor performance such as abandoning work, leaving Contract incomplete or financial failures/weaknesses etc.
- (xiv) **The water and electricity connection shall be facilitated by Shrine Board. The recurring cost in this regard shall lie in the scope of "selected bidder". The arrangement of power back-up (DG set etc.) required in case of power failure shall lie in the scope of the selected bidder**
- (xv) The successful Bidder shall have to enter into an Agreement with the Shrine Board within 30 days from the date of issuance of award of the Contract.
- (xvi) In case of any dispute or clarification in Tender, the decision of the Chief Executive Officer/Addl. Chief Executive Officer, SMVDSB shall be final & binding.
- (xvii) The contract as a whole or part thereof is Non-Transferable.
- (xviii) The selected vendor shall be allowed to use the built-up infrastructure of SBsubjecttoadherencetothetermsandconditionsenforcedbytheShrineBoard from time to time; including (but not limited to) the following:
 - a) NotallowingemployeesofvendortoparticipateinanytradeUnionactivities or agitation.
 - b) Ensuring safety precautions in the process of packaging/adoption of fire safety norms.
 - c) Maintaining of cleanliness and hygiene.
 - d) Adhering to prescribing qualification and suitability norms for the engaged employees.
 - e) The Shrine Board not owning any responsible for any injury, accident

disability, or loss of life that may take place while on daily or conservancy duties (any compensation or expenditure towards treatment of such injury, accident, or loss of life being the sole responsibility of the selected bidder).

f) Mandating selected bidder to make arrangement towards health insurance, accidental and disability coverage and domiciliary treatments of all personal engaged by him under their pay roll.

g) The firm shall comply with all Statutory requirements.

(xix) **Penalty:** The SMVDSB will be at liberty to treat the following reasons as violation of agreement deed attracting monetary penalty of Rs. 5,000/- (Rupees Five thousand only) per violation on the basis of complaint received and verified to be of genuine nature. In case of reoccurrence of such act, an additional penalty of Rs. 10,000/- shall be imposed for another five to six times. If such complaints keep pouring-in, a final warning with penalty shall be imposed. Furthermore, in case no stern action is taken by the firm, the Contract / agreement shall be revoked without giving any further notice. The penalty on complaints shall be imposed for maximum of 07 times on following terms:

- Complaint about quality and quantity or violation of Legal Metrology Rules, 2011.
- Complaint about the misbehavior of the employees of the selected bidder
- For non-wearing of proper uniform by the employees of the Selected bidder
- Complaint about poor quality of dry fruits used in New Pouch Prasad Pouch.
- If any of the employees/workers/labour is caught smoking or Making use of any tobacco products / alcohol or pan chewing within or around the location allotted to them.
- Improper disposal of waste generated from the licensed space.
- Violation of any terms & conditions mentioned in the agreement deed.
- Non-maintenance of personal hygiene by the employees of the selected bidder.

14. The Chief Executive Officer, SMVDSB, reserves the right to withdraw/relax/interpret any of the terms and conditions mentioned hereinbefore; in such a situation the selected bidder shall be given sufficient time to take the changes into account.

15. Notwithstanding the sub-divisions of the documents into separate sections or otherwise, every part of each section/part/point or paragraph, shall be deemed to be supplementary to and complimentary of every other part and shall be read into totality as part and parcel of the contract.

16. **Termination:**

(i) SMVDSB reserves the right to terminate the Contract at any time by giving 02 month prior notice in writing to the Contractor. In the event of termination /revocation of the Contract, SMVDSB shall be under no obligation to give any reason for its decision to put the Contract to an end. In the event of termination / revocation of the Contract, the selected bidder agrees that it shall have no claim of any nature / kind against SMVDSB.

(ii) The selected bidder can apply for termination of the contract at any time by serving 02 months prior notice in writing to SMVDSB communicating its intentions with valid reasons.

- (iii) **Performance Review**: The performance of the selected bidder shall be reviewed on regular basis. Unsatisfactory performance can lead to termination of the Contract and forfeiture of the Security Deposit by SMVDSB.
17. **Force Majeure**: Any failure or omission to carry out the provisions of the order shall not give rise to any claim by one party against the other, if such failure or omission arises from an "Act of God" which shall include all acts of Natural Calamities such as fire, flood, earthquakes, hurricanes or any pestilences or from civil strikes, compliances with any statute or regulations of the Government lock outs and strikes, riots, embargoes or from any other reasons beyond the control of the parties including the war (Whether declared or not) Civil War or State of Insurrection.
18. **Arbitration**: In case of any dispute arising between the parties hereto, relating to the supply of "Pouch Prasad" and all matters connected therewith, both parties shall make every effort to resolve it amicably by direct informal negotiation. If the parties have not been able resolve the dispute amicably, then such disputes/differences shall be resolved by arbitration as per "The Arbitration and Conciliation Act,1996 (read with up to date amendments).
- i. Either party may request other of its intention that a dispute be submitted to Arbitration and both the parties shall meet within 15 days from the date of receipt of such request, to select a sole arbitrator mutually for the resolution of dispute and venue/seat of Arbitration shall be at Jammu.
 - ii. In the event that the parties cannot agree upon the selection of the sole Arbitrator, either of the party or both of the parties may move an application before the Hon'ble High Court at Jammu, under The Arbitration and ConciliationAct,1996 (read with up to date amendments), for the appointment of a sole Arbitrator with seat/venue at Jammu for the resolution of disputes between the parties.
19. **Jurisdiction**: All disputes arising hereto are subject to Jurisdiction of the Courts of Law at Katra, Reasi and Jammu.
20. **Important General Instructions for the Bidders**:
- (a) If at any stage, any dispute arises between the tenderer(s)and **SMVDSB**, the terms and conditions of the e-NIT shall prevail over the offer of the tenderer. Further the tenderer submitting his tender would be deemed to have considered and accepted all the terms and conditions. No enquiries (verbal or written) shall be entertained in respect of acceptance or rejection of the tender.
 - (b) In case of any contradiction in the provisions of the e-NIT or the interpretation of any clause, the decision of the Competent Authority shall be final and binding.
 - (c) The decision of the technical committee shall be final and binding on the tenderer(s).
 - (d) Representation if any, related to technical bid(s) shall have to be made within 15 days from the date of opening of technical bids and thereafter no representation whatsoever shall be considered.
