

7. अतिरिक्त परफॉरमेन्स गारंटी मात्र Fixed deposit Receipt (FDR) के रूप में मान्य होगा।
8. अनुबंध न करने की स्थिति में निविदाकार की अमानत राशि (Bid Security) राजसात करने की कार्यवाही की जायेगी। ऐसे निविदाकारों को कम से कम 02 वर्ष के लिये प्रतिबंधित करने हेतु प्रस्ताव संचालनालय, नगरीय प्रशासन एवं विकास को प्रेषित किया जायेगा।
9. यदि अनुबंध में निर्धारित अवधि में कार्य पूर्ण नहीं होने पर संविदाकार द्वारा समयावधि बढ़ाने की मांग की जाती है, तो ठेकेदार की मांग पर बढ़ाई गई समयावधि, के लिए मूल निविदा शर्तों की पेनाल्टी के अतिरिक्त अव्यवहारिक दरों के मामले में अतिरिक्त पेनाल्टी भी ली जायेगी। अतिरिक्त पेनाल्टी प्रत्येक एक माह की समयवृद्धि के लिए अतिरिक्त परफॉरमेन्स गारंटी का 1/12 भाग होगा।

ELIGIBILITY FOR BIDDERS:

- (a) At the time of submission of the Bid the bidder should have valid registration with the Government of Madhya Pradesh, PWD in the appropriate class. However, such bidders who are not registered with the Government of Madhya Pradesh and are eligible for registration can also submit their bids after having applied for registration with appropriate authority.
- (b) The bidder would be required to have valid registration at the time of signing of the Contract.
- (c) Failure to sign the contract by the selected bidder, for whatsoever reason, shall result in forfeiture of the earnest money deposit.
- (d) Tenderer will have to submit Scanned copy of EPF Registration.
