6. It is mandatory for the bidder to submit the ISO certificate.
7. If the quality of powder is not found proper in the test report, the bidder will ensure to take back the goods at his own cost.
8. The Bidder Must Submit valid license of company registration, MSME, Registration Certificates, GST certificate, Pan Card, Copy of Organization/Firm.
9. The Buyer Reserves the Rights for Any Changes/ Cancellation/ Rejection of Any Part or Whole Bid, Without Assigning Any Reason What So Ever.
10. An undertaking on rupees 100/- non judicial stamp paper should be given by Bidder; that all the Information provided are true and all the documents uploaded online all true.
11. Prior to signing of the Contract the bidder to whom LOA has been issued shall have to furnish performance security of 3% of contract the amount in form of FDR /Bank Guarantee in favour of Chief Municipal Officer Itarsi, Dist-Narmadapuram.
12. Competent authority may reject the bid for award if it determines that the bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the Contract
