Terms & conditions

- 1 1 Year warranty should be compulsory. Defective tent cooler/Fan shall be replaced within 3 days from the date of complaint at their own cost.
- 2 The items will have to be supplied at GMC . No transportation/Cartage charges will be provided for the same.

- 3 It is mandatory to write the name of GMC on Tent Cooler/Fan
- 4 All the tentcooler/FAn should be delivered & put in appropriate place within time period from the date of receipt of the purchase order.
- 5 GMC reserves the right to accept/reject any bids/all bids without assigning any reason.
- 6 The work/ supply order will be awarded to the bidder quoting the overall lowest price. The work will be effective from the date of award of the contract subject to submission of performance Bank Guarantee (PBG) to the tune of 3 o/o of Annual Contractual value with validity of 365 days .

 - Slippage up to 25% in financial target during the milestone under consideration - 2.5% of the work remained unexecuted in the related time span.
 - Slippage exceeding 25% but Up to 50% in financial target during the milestone under consideration - 5% of the work remained unexecuted in the related time span..
 - Slippage exceeding 50% but Up to 75% in financial target during the milestone under consideration -7.5% of the work remained unexecuted in the related time span
 - Slippage exceeding 75% in financial target during the milestone under consideration -10% of the work remained unexecuted in the related time span.
