ELIGIBILITY FOR BIDDERS:

1. At the time of submission of the Bid the bidder should have valid Authorised Dealer/Manufacturer registration
2. Failure to sign the contract by the selected bidder, for whatsoever reason, shall result in forfeiture of the earnest money deposit.

4. The bidder would be required to have valid trade licence registration issued by GMC Gwalior.

Terms & Conditions

1. Led fittings will have to be supplied against supply order/demand from electrical department.
2. Authorised Dealer/Manufacturer of mentioned makes to be provided at time of bidding.
3. The vendor shall be provide warranty of the LED streetlight fixtures supplied under this contract, the agreement period (2 year) covering any manufacturing, defects,high voltages.
4. Defective Led fittings to be repaired/replaced within 7 days after that Rs 50 per week per light will be deducted from security deposit amount .

5. After opening of the financial bid bidders have to provide sample of required LED fitting in within 03 days and financial bid will be opened for those bidder whose sample is passed.
6. system lumens output with efficacy > 110 lm/W. luminaire having color temp 6500K & 50000 burning hrs life with minimum @ L 70
7. The colour rendering index of LED light should be more than 70. Luminaire comprises of driver, PF 0.95 & surge protection 10 KV.
8. It is mandatory to write the name of GMC 2026 on led.
9. Housing made of pressure die cast aluminium with heat resistant flat glass, IP66 protection.
10. Vendor shall ensure the warranty of the supply till the warranty period 2 year supply of spare parts as per the requirement of department store.

Slippage exceeding 50% but **Up** to 75% in financial target during the milestone under consideration -7.5% of the work remained unexecuted in the related time span


