However, such bidders who are not registered with the Government of Madhya Pradesh and are eligible for registration can also submit their bids after having applied for registration with appropriate authority.
- (b) At the time of submission of the Bid The bidder should have valid 'A' Class Electrical License issued by the Govt. of MP.
- (c) The bidder would be required to have valid registration (Trade License issued by GMC) at the time of signing of the Contract.
- (d) Failure to sign the contract by the selected bidder, for whatsoever reason, shall result in forfeiture of the earnest money deposit.

3. **Pre-qualification** – Prequalification conditions, wherever applicable, are given in the Bid Data Sheet.

4. **Special Eligibility** – Special Eligibility Conditions, if any, are given in the Bid Data Sheet.
