3. Tenderer will have to submit Scanned copy of EPF Registration.
4. The Bid Document can be purchased only online from as per due date on <http://mptenders.gov.in>.
5. The bidder would be required to have valid trade licence registration at the time of signing of the Contract issued by GMC Gwalior.

Terms & conditions

1. All the items to be supplied should be new, of good quality and standard and as per the technical specifications mentioned in technical bid document.

2. The equipments will carry one years on site comprehensive OEM warranty. Warranty period will start from the date of successful installation of all the items at site.
3. For full completion of the work, contractor shall at his own expense arrange & furnish all necessary work tools, tackles, scaffolding, tagaries, mugs, scrappers, wire brushes etc. that may be required to complete the work under contract.
4. The tenderer should not have been debarred or blacklist by any Central/ state government department of india. An affidavit to that effect on non judicial stamp paper of 10/- duly notarised must be enclosed with the bid.
5. Contractor shall take all precautionary measures to avoid any damage to adjoining property. All necessary arrangement shall be made at his own cost. In case it's happen contractor may repair the damage property at his own cost and no claim in this regard will be entrained
6. The firm shall be responsible for any injury or accident to the person(s) employed by them. This GMC shall have no liability, financial or otherwise, for any harm/damage/injury incurred by the manpower deployed by the contractor in the courseof performing the work. Neither the contractor nor his workers shall have any claim on this GMC for compensation or financial assistance on this account.
7. The work will be awarded to the bidder quoting the overall lowest price. The work will be effective from from the date of award of the contract subject to submission of performance Bank Guarantee (PBG) to the tune of 3 % of Annual Contractual value with validity of 365 days .
8. It is mandatory to write the name of the councillor with radium or board on the watercooler.
9. After the Expiry of the supply order deadline, the accounts department will have full authority to deduct 0.25 percent from the original bill per week.
