The Bidder shall furnish Earnest Money Deposit (EMD) for the amount as mentioned in column 3 (as shown in table – 1.1) online through the e-procurement website of Government of Jharkhand i.e. [jharkhandtenders.gov.in](http://jharkhandtenders.gov.in). Further, the bidder shall ensure to maintain their bank account used for making payment towards EMD operational till the finalisation of Tender formalities as the EMD amount shall be

refunded only in that account. In case otherwise, it would be the responsibility of the bidder.

11. Tenderer(s) shall upload Scanned copy in PDF format/Digitally Signed copy of his/her receipt of Bid Security, TIN, PAN, Audited Turnover (Unique Document Identification Number (UDIN) has been made mandatory by ICAI from 1st July 2019 for all audit/Assurance/Attest Function. Hence Audited Turnover and Balance sheet containing UDIN no from financial year 2019-20 is mandatory for bidders. Audited Turnover Summary must contain UDIN No.), 26AS of Income Tax, Work Experience, Partnership Deed or Article of Association/Memorandum, Undertakings, Affidavits, E.P.F., GST, ..... etc.
12. Bidders should mandatorily have GST registration with Principal Place of Business as Jharkhand, however, bidders who do not have GST registration in the state of Jharkhand shall:
  - i. Submit an undertaking confirming that they will get themselves registered under GST in the state of Jharkhand in case of award of work in the tenders floated by respective ULBs/ Authorities subsequent to completion of the Empanelment Process.
  - ii. In case of award of work in the tenders floated by respective ULBs/ Authorities subsequent to completion of the Empanelment Process the bidder shall get themselves registered under GST in the state of Jharkhand and submit the details to the tender inviting authority at the time.
13. Uploaded documents of successful bidder will be verified with the original before signing the agreement. The successful bidder has to provide the originals to the concerned authority on receipt of such a letter, which will be sent though registered post or speed post or delivered by hand.
14. Bidders in order to participate in the bidding process have to get 'Digital Signature Certificate (DSC)' as per Information Technology Act-2000 to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get the above-mentioned digital signature certificate from any approved vendors (CCA). Bidders, who already possess valid Digital Certificates, need not procure new Digital Certificate.
15. A pre-bid meeting will be held on 24<sup>th</sup> April, 2026 at 15:00 Hrs in the office of JUIDCO Ltd., Ranchi, Jharkhand to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in the bidding document.
16. The undersigned reserves the right to accept or reject all proposals without assigning any reason. It also reserves the right to postpone or to cancel the invitation and pre-bid meeting.
