

3. Agreement with Bidders selected through e-procurement shall be eventually drawn in PWD Form No. F2.
4. The work shall be completed as per NIT from the date of written order to commence the work. The items of work, plan, specifications or any information in connection with the work can be seen in the office of the Chief Executive Officer, Dhanbad Municipal Corporation, Dhanbad on any working day during office hours before submitting bid.
5. **The Bidder must use the designated online payment system on the e-procurement portal to pay the EMD and Cost of Tender Paper (Non Refundable). 6. **The Tenderer shall duly complete the tender document online and shall upload clear and legible scanned copies of the requisite documents, as specified in the NIT, including but not limited to the following:-**
 - (i) Registration Certificate under GST (Form GST REG-06) and up-to-date valid GST Returns(3B) must be submitted. The return in Form GSTR-3B must be filed for any month/quarter of the last financial year
 - (ii) Income Tax Returns for the last three Assessment years shall be uploaded.
In the case of a newly established firm or a Private Limited, the Proprietor or Partners, as applicable, shall submit their respective Income Tax Returns (ITR).
 - (iii) Registration Certificate, Under UD&HD, Jharkhand. नगर विकास एवं आवास विभाग की अधिसूचना सं0 8/नियमावली/105/ 2016/न0वि0 - 6351 दिनांक 22 नवम्बर 2016 के अनुरूप मान्य होगा। (संलग्न).
 - (iv) Valid or Authorised Character Certificate (Valid for Six Months Only from Date of Issue). Issued by DM/SSP or SP Or Relating to the Regional nativeness of the Contractor. Validity of Character Certificate would depend upon whether the validation period given on character certificate would fall under the last date of submission of bid of published NIT.

(iv.1) In case of Partnership Firms & Private Limited, all the shareholders have to submit their individual valid character certificate. If Power of Attorney is given to somebody then its holder's character certificate should be submitted.

(v) **Tender amounting 25 lakhs and above**, the Contractor Should have 50% experience of the work Value in execution of Similar Nature Of Civil Works Completed in a Govt. Department in the Last Five Financial Year. The actual date of completion of each work must be clearly mentioned in the experience certificate issued by the Executive Engineer (EE) or an officer of equivalent rank. The said certificate shall be issued by the concerned Government Department and shall bear a clearly readable issue number and date of issue. If found nil the bidder's bid will be rejected.

For tenders amounting to below ₹25 lakhs, no prior experience is required.

The uploaded scanned experience certificate shall be clear, legible, and readable in all respects.

(vi) Affidavit regarding Correctness of information furnished by bidder with the bid (Annexure – 2)

(vii) The bidder/ tenderer shall submit a duly sworn affidavit affirming that the required Tools and Plant, in working condition, shall be arranged during the execution of the work through hire, lease, or other lawful means, and shall, whenever called upon by the concerned authority, furnish the same along with owner consent, vehicle registration numbers, and complete details thereof for verification. **This condition shall be applicable for tenders up to ₹50 lakhs.**

For tenders above ₹50 lakhs: Authorized & Valid Certificate (Sale Invoice) of the required Tools and Plants as specified in the NIT shall be submitted,

OR,

Alternatively, an affidavit stating that the required Tools and Plants shall be arranged by any lawful means (hire or lease) by the bidder during execution of the work. In such affidavit, clear approval and consent of the actual owner of the Tools and Plants shall be mandatorily included, along with the original certified invoice details, registration number, and complete particulars of the equipment, duly endorsed by the owner.


10. Tendere(s) shall enclose scanned copy of his/her/their registration & exemption certificate (if any) in absence of which the tender(s) may not be considered.

11. Registration Certificate under FORM GST REG - 06, Character Certificate & Letter of Registration as contractor shall be submitted by the tenderer otherwise it may be rejected.

12. Authority reserves the right to reject any or all the tender(s) received without assigning any reasons thereof.

13. The BOQ amount can be increased or decreased and the earnest money deposit (EMD) Corresponding to revised BOQ amount will have to deposit through online.

14. In the case of successful tenderer (hereinafter called contractor) the amount of E.M will be transferred towards Initial Security Deposit in such a manner so that the security deposit will form part of 5% of the approved amount of the approved tender & the remaining 5% shall be recoverable from the subsequent bills of the contractor.
15. Security Deposit amount (as applicable) has to be taken at the time of agreement shall be deposited by **Demand Draft/Banker's Cheque/Fixed Deposit of any Nationalized Indian Bank/Scheduled Indian Bank** in Favour of **Chief Executive Officer, Dhanbad Municipal Corporation, Dhanbad Payable at Dhanbad Only**.
16. The Procedure for refund of EMD Amount of the unsuccessful bidder will be decided after the work order issued by the tenders inviting authority.
17. Bidders should ensure not to close the bank account they have used for depositing Tender Fee/ EMD.
18. The Earnest Money of the successful tenderer (hereinafter called the contractor) which accompany the tender will be forfeited in case the tenderer declines to sign the agreement or fails to deposit Security Money within 10 days of being called upon to do so.
Those contractors, who are exempted from depositing E.M., will deposit initial security money within 10 days of being called upon to do so. If they fail to do so or decline to sign the agreement within the stipulated period, the requisite sum of money will be forfeited by way of adjustment from any sum to be paid to him by the department for other works, including his security money and in addition he may be Black Listed and subsequently his registration may be cancelled.

20. In case of RCC/PCC work exceeding 50 m³ in the project, the tenderer must submit an undertaking (affidavit) stating that the work will be carried out using an automatic concrete batching and mixing plant and a mechanical vibrator.
21. In a particular financial year one contractor will not be allowed more than one work without getting completed the work already allowed to him but in case of in any group tenders are received but all are awarded in that case committee will decide for award of work as per criteria
22. Payment against works will be made subject to availability of fund.
23. Each uploading shall be digitally signed by the bidders
24. Defect Liability Period shall be 03 (Three) years after the actual date of completion.
25. Uploaded documents of valid successful bidders will be verified with the original before signing the agreement. The valid successful bidder has to provide the originals to the concerned authority on receipt of such letter, which will be sent through registered post
