NOTICE INVITING E-TENDER

On behalf of Chairman, U P Jal Nigam (Urban), C.&D.S., U.P. Jal Nigam (Urban) invites online bids on Design, Engineering, Procurement and Construction (EPC) basis through e-tendering from eligible contractors/firms in two bid system for the following work :-

2. Prospective bidders are advised to regularly scan through website of “<https://etender.up.nic.in>” as corrigendum/amendments etc., if any, will be notified on this portal only and separate advertisement will not be made for the same.
3. Bidders are advised to carefully note the eligibility/ qualification requirements prescribed for the bid. They should submit their bids only if they consider themselves eligible and are in possession of all the requisite documents.
4. The Bid should be valid for 120 days from the last date of submission of bids. Bid once submitted, cannot be withdrawn.

5. If the date of opening of technical bid happens to be a holiday, the bid shall be opened on the next working day at the same time for which no separate communication shall be sent.
6. Bidders having criminal record will not be allowed to participate in Bid process.
7. The bidders whose work has been rescinded of any contract during last 05 (five) years shall not be eligible for participation in this tendering. The bidders should upload an affidavit on non-judicial stamp paper of Rs. 100/- (Rupees One Hundred Only) along with the bid document mentioning that no work awarded to firm (bidding in this tender) has ever been rescinded for default of contractual obligations during last 05 (five) years.
8. A person registered with any State Bar Council will not be eligible to participate in the Bid.
9. In case, the last date of submission/opening of bid is extended, the enlistment of contractor should be valid on the original date of submission of bids.
10. The bidder is required to have Class III-B (Signing and Encryption) Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities. The DSC should be valid at least for a period of six months from the date of start of bidding. After submission of bid the contractor can re-submit revised bid any number of times but before the last time and date of submission of bid as notified. While submitting the revised bid, the contractor can revise the rate any number of times.
11. The bidders are required to upload the scanned copy of original documents with their documents.
12. Non-refundable e-tender fee must be submitted by RTGS/NEFT only in A/c Director, C&DS (Unit-01), UP JAL Nigam (Urban), Bengaluru for an amount of Rs. 23,600/- inclusive of GST.
13. C.&D.S., U.P. Jal Nigam (Urban) reserves the right to accept or reject any application without assigning any reason or incurring any liability whatsoever.
14. This NIT and other information/corrigenda and Instruction for bidders posted on website shall form part of bid document.
15. The bidders have to submit an undertaking that "I/We will either obtain valid electrical license at the time of execution of electrical work or associate contractors having valid electrical license of eligible class."
16. If the Bidder feels that technical credentials of his own or any other bidder have been wrongly evaluated/verified, he may raise objections by E-mail only within 02 (two) working days during office hours. from the date of uploading of result. Opening of financial bid will be scheduled accordingly. No requests/objections shall be entertained beyond above limit, else it may be treated as an obstruction in tender process and shall be dealt with accordingly.
17. The competent authority on behalf of Chairman, U P Jal Nigam (Urban) reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
18. The bidder Should be registered with Construction & Design Services U.P. Jal Nigam (Urban) in appropriate class and category of works as specified in Regulations for Classification and Enlistment of Contractors and its registration certificate shall be uploaded with the bid documents.

19. Minimum Eligibility Criteria:

The interested bidders should meet the following minimum qualifying criteria:

A. Work Experience:

- (i) Should have satisfactorily completed the following works in India during past Seven (7) Years ending previous day of last date of submission of tenders:
 - a. Three *Similar Works each costing not less than 40% of the estimated cost put to tender, i.e. Rs. 655.52. lacs.
- OR
- b. Two *Similar Works each costing not less than 50% of the estimated cost put to tender, i.e., Rs. 819.40 lacs.

OR

- c. One *Similar Work costing not less than 80% of the estimated cost put to tender, i.e., Rs. 491.64 lacs.
- d. Apart from the above one work of similar nature of value 30 % of Estimated cost put to tender as given above, if not covered in A (a),(b).(c)., must be completed in any access controlled campus such as Educational institute/Army cantonment/Medical colleges/running University/Electric Sub Station /Power plant premises/ Jail premises or any other institution where access is restricted , must be submitted by the bidder. All the works should be compositely executed under one agreement **and provided**, should have been executed with some Central/ State Government Organisation/ Central Autonomous Body/ Central/ State Public Sector undertaking/Nigam
- e. Apart from the above one work of similar nature (with Firefighting and installation of lift) of value 30 % of Estimated cost put to tender as given above, if not covered in A (a),(b).(c), (d)., must be completed and be submitted by the bidder. All the works should be compositely executed under one agreement **and provided**, should have been executed with some Central/ State Government Organisation/ Central Autonomous Body/ Central/ State Public Sector undertaking/Nigam

Work experience certificate should be certified by an officer not below the rank of Executive Engineer/ Project Manager or equivalent.

“Similar Work” shall mean construction of Non Industrial building Project(s) comprising Construction of a RCC framed structure) including finishing works, water supply, drainage & sanitary installations, electrical works, and associated development works. All should be compositely executed under one agreement **and provided**, at least one completed work of similar nature (either part of a or b or c) costing not less than the amount equal to 40% of the estimated cost put to tender should have been executed with some Central/ State Government Organisation/ Central Autonomous Body/ Central/ State Public Sector undertaking/Nigam and remaining work experience should satisfy the requirements of a, b or c above with works successfully executed for reputed private organisations which must be a duly incorporated entity under the companies act 1956/2013.

Certificates issued by private organisations must be supported by Form 26AS/TDS certificate. The certificate should clearly indicate scope of work, date of completion, completed value, name of work, agreement/order no., date of start etc. in Form VI-B to verify eligibility wherever required, the Certificate should also be supported by schedule/ final bill (certified).

e. (i) **Escalation/Enhance Factor for work Experience:**

The Bidders should have experience of execution of works of similar nature including construction, supply, installation, testing & successful commissioning and other related associated / allied appurtenant works as applicable.

The value of executed works shall be brought to current cost level by enhancing the actual value work at the rate of 7% per annum at simple rate as per following factor. It will be calculated from the last date of completion of work to previous day of last day of submission of tenders.. A typical illustration is as below.

- iii) The past experience in similar nature of work should be supported by certificates issued by the client's organisation. In case the work experience is of Private sector the completion certificate shall be supported with copies of Letter of Award and copies of Corresponding TDS Certificates. Value of work will be considered equivalent to the amount of TDS Certificates. Experience should be in the name of the bidding company and not in subsidiary/ associate company/ Group Company etc. Experience as part of a Joint Venture or Consortium or Special Purpose Vehicles will be considered based on the applicant / bidder share by Value in very joint venture or Consortium. Own works / work under the same management / own certification of the bidder shall not be considered for pre-qualification.
- iv) The value of executed works shall be brought to the current level by enhancing the actual value of work done at a simple rate of 7% per annum, calculated from the date of completion to previous day of last day of submission of tenders.
- v) Joint-ventures (JV) or Special Purpose Vehicles (SPV) or consortium of firms / companies shall not be allowed and the bidders should meet the above criteria themselves.

B. Financial Strength:

- i) Should have average annual financial turnover on construction works during the last 3 consecutive **years ending 31.03.2025** equal to at least 50% of the estimated cost of work. Year in which no turnover is shown would also be considered for working out the average. This should be duly audited by Chartered Accountant with his Seal/ signatures and registration number mentioned compulsory UDIN of Chartered Accountant.
 - ii) The balance sheets, Statement of Profit & Loss Account and Notes to Accounts should be duly audited and certified by a Chartered Accountant with his seal / signatures and firm registration number. The year in which no turnover is shown, would also be considered for working out the average. The turnover should be of the Bidding Company and not for Group Company or subsidiary company etcetera Turnover shall be duly certified by a Chartered Accountant (CA) with his seal / signatures and registration number & must mention the work completed/running. Certificates issued by CA shall mandatorily accompany with UDIN.
 - iii) Should not have incurred any loss in more than two years during the last five audited balance sheets (audited by statutory auditor of firm) of consecutive years ending **31.03.2025** At the time of submission of bid, contractor has to upload **Certificate from Chartered Accountant mentioning year wise financial turnover on construction work** of last 5 years. The bidders are required to upload and submit summarised page of Balance Sheet of last Financial Year (Audited) and also page of summarised Profit & Loss Account (Audited) for last three years.
 - iv) Should have a solvency of 40% of cost of work put to bid for which a solvency certificate issued by any scheduled commercial Bank/District Magistrate shall be submitted in Form-"II-B". The validity of the solvency certificate shall be taken as 365 (Three Hundred and Sixty-Five) days from the date of issue by the Bank and it should be within the validity period on the last date of bid submission.
 - v) Net Worth of the company /firm as on 31st March of previous Financial Year, i.e., 31st March 2025 should be positive.
 - vi) The Tender Document as uploaded can be viewed and downloaded free of cost by anyone including intending tenderer. But the tender can only be submitted after uploading the mandatory scanned documents such as UTR No. of RTGS/NEFT up to Rs. 50.00 lacs (Rs. fifty Lacs) shall be deposited through RTGS/NEFT and its confirmation (date & UTR no.) shall be uploaded and rest amount of EMD if it exceeds Rs. 50.00 lacs (Rs. fifty Lacs) shall be deposited in form of BG/FDR of any Scheduled Commercial Bank **in favour of (Director, C&DS, Unit-01, U.P. Jal Nigam (Urban), Bengaluru)** and the scanned copy of original BG/FDR on prescribed form-B should be uploaded. All other documents shall be as per Notice Inviting e-tender. Validity of EMD shall be at-least 45 days beyond the bid validity period from the date of opening of Technical Bids (i.e. 165 days)
- 21.** The tenderers are required to quote strictly as per terms and conditions, specifications, standards given in the tender documents and not to stipulate any deviations. The bidders are advised to submit complete details with their bids as Technical Bid Evaluation will be done on the basis of documents uploaded on website by the bidders with the bids. The information should be submitted in the prescribed proforma. Bids with Incomplete/Ambiguous information will be rejected.
- 22.** The bidders are advised in their own interest to submit online their bid documents well in advance from last date/time of submission of bids so as to avoid problems which the bidders may face in submission at last moment /during rush hours.

However, after submission of the tender the tenderer can re-submit revised tender any number of times but before last time and date of submission of tender as notified.

23. When it is desired by C.&D.S. U.P. Jal Nigam (Urban) to submit revised financial tender then it shall be mandatory to submit revised financial tender. If not submitted, then the tender submitted earlier shall become invalid.
24. On opening date, the tenderer can login and see the tender opening process.
25. Contractor can upload documents in the form of JPG format and PDF format.
26. Contractor to upload scanned copies of all the documents including valid GST registration ESI & EPF registration/ PAN No. as stipulated in the tender document.
27. If the contractor is found ineligible after opening of tenders, his tender shall become invalid and cost of tender document and processing fee shall not be refunded.
28. Not with standing anything stated above, C.&D.S., U.P. Jal Nigam (Urban) reserves the right to assess the capabilities and capacity of the tenderer to perform the contract, in the overall interest of C.&D.S., U.P. Jal Nigam (Urban). In case, tenderer's capabilities and capacities are not found satisfactory, C.&D.S., U.P. Jal Nigam (Urban) reserves the right to reject the tender.
30. **Certificate of Financial Turnover:** At the time of submission of tender, the tender shall upload Affidavit/Certificate/UDIN from Chartered Accountant mentioning Audited Financial Turnover of last 3 years ending as on 31st March 2025 . There is no need to upload entire voluminous balance sheet. However, one page of summarised Balance Sheet (Audited) and one page of summarised Profit & Loss Account(Audited) for last 03 years shall be uploaded and submitted in hard copy also when asked to do so.
31. The tenderer(s) if required, may submit queries, if any, through E-mail to the tender inviting authority to seek clarifications latest by 72 hrs. prior to last date & time of submission of bid in the original NIT prior to any corrigendum. C.&D.S., U.P. Jal Nigam (Urban) will reply only those queries which are essentially required for submission of bids. C.&D.S., U.P. Jal Nigam (Urban) will not reply the queries which are not considered fit like replies of which can be implied /found in the NIT/ Tender Documents or which are not relevant or in contravention to NIT/Tender Documents.
32. In compliance to G.O. No.01/2018/3070/78-2-018/42आई0टी0/2017/(22) dated 03.01.2018, the bidder has

The bidder shall deposit tender fees and earnest money separately in account mentioned as above and quote UTR No., date and amount of deposit in the capability statement available on portal. Further he shall upload digitally signed copy of original receipts of bank showing clearly the above details. *It is made clear that Tender Fee and Earnest Money deposited in any other form and account shall render the bid non-responsive.*

- 33.** The bidder will, in addition to other documents, upload scanned and digitally signed copies of originals of proof of cost of bid document i.e. Tender Fees, Earnest Money deposit as described above, Solvency Certificate and Standard Affidavit in prescribed form.
- 34.** All the documents as specified in the technical bid/eligibility bid document should be uploaded within the period of bid submission. The department will not be liable for incomplete/inaccurate /non-submission of bid for any reason whatsoever including technical reasons. **It is made clear that separate submission of originals of any documents, other than scanning and uploading them, are not required unless called for after opening of financial bid.**
- 35.** The bid submission shall become invalid if:
- (i) The bidder is found ineligible.
 - (ii) The bidder does not upload all the documents, including PAN & GST registration, as stipulated in the bid document.
 - (iii) If any discrepancy is noticed between uploaded documents and originals/hard copies submitted later, if required by C&DS, U.P. Jal Nigam (Urban) for verification.
 - (iv) If subsequent to due date of submission of bid and after its submission bidder makes any further communication/ representation with the department with regard to the bid (whether technical or financial) than otherwise called for by the undersigned as a clarification.
 - (v) If a bidder does not quote any percentage above/below on the total amount of the tender or any section/sub head in percentage rate tender, the tender will not be considered as lowest bid.
- 36.** In order to safe guard against contractors leaving the works after quoting very low rates below the BOQ amount, the Bidder shall have to submit additional security/performance security to be deposited by the firm shall be at following rates: -
- a. Upto 10% below the estimated cost of works - Nil
 - b. Above 10% below the estimated cost of works - @ 0.50% for each 1.00% quoted below.
- 37.** The available bid capacity of the bidder at the expected time of bidding shall be more then the total estimated cost of the work for which the tender is invited.

The available Bid Capacity shall be assessed using following formula :-

A= Maximum turnover during the last five financial year (corrected to the current level of value).

N= Stipulated period of execution of the work for which the tender is invited in years.

38. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstance which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site, whether he inspect it or not, and no extra charge consequent to any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all others services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the instructions, scope and specifications of the work to be done and local conditions and other factors having a bearing on the execution of the work.
39. Canvassing whether directly or indirectly, in connection with bids is strictly prohibited and the bids submitted by the bidders who resort to canvassing will be liable for rejection & will be debarred from future tender in C.&D.S., U.P. Jal Nigam (Urban).
40. The bidder shall not be permitted to bid for works under supervisory control of General Manager and Project Manager concerned who is responsible for execution of work, in which his near relative is posted. He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any officer in the C&DS. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of C&DS and make him liable for black listing.
41. No Engineer or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the STATE GOVERNMENT/State department Undertaking is allowed to work as a contractor for a period of two years after his retirement from Government service, without the prior permission of the Government of U.P. in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of U.P. as aforesaid before submission of the bid or engagement in the contractor's service.
