Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instruction to Bidders to qualify for the award of the contract.

3. Time allowed for completion of work has Column No. 12 including rainy season.
4. According to provisions of Government Order No. 26/2017/2778/78-2-2017-97 IT/2017 TC Date 05-09-2017 and E-in-C Circular No.-155Camp/CE (HQ-1)/Circular/2019-20 Dated 22.04.2019, the Bids must be accompanied with the copy of UTR (Unique Transaction Receipt) Bid Security (EMD) and tender cost of the amount specified for the work in the table. Bid Security and Tender Cost should be deposited online as per follows :-
  - A. Cost of Bid Document: As per Column No.-6 (Non-Refundable) to be deposited in account of UP e-tender Online account through e-tender portal by Internet Banking only. All concerned please note that the bidding process will not move onward if the Bid Document's Cost (Tender Fee) is not paid through e-tender portal by Internet Banking.
  - B. Bid Security (EMD): Bid must be accompanied with security of the amount specified for the work in the table as per Column No.-5. Bid Security will be deposited in the account of UP E-tender online account through e-tender portal by Internet Banking only. All concerned note that the bidding process will not move onward if the bid security (EMD) is not paid through e-tender portal by Internet Banking. No other form of Bid security will not be accepted.
  - C. The Bidders are required to submit the following:
    - I. Cost of Bid document (Tender Fee):- Certificate of proof of payment in the account of UP E-tender online Account by Internet Banking which will be generated when payment made through e-tender portal by Internet banking.
    - II. Bid Security (EMD):- Certificate of proof of payment in the account of UP E-tender online account by Internet Banking which will be generated when payment made through e-tender Portal by Internet Banking.
5. The bids shall remain valid for acceptance for a period of 90 Days from the last date of submission of bids. Bids once submitted cannot be withdrawn.  
E-tendering is to be adopted for this tender. Bidding documents can be downloaded from or uploaded to website <http://etender.up.nic.in> & Technical sheet uploaded on Prahari website <http://wms.uppwd.gov.in/Prahari/>
6. As per G.O. the Bid documents and F.D.R./Demand Drafts/ Pay Orders/ security certificate (in original) will be deposited personally in the office of "Executive Engineer Construction Division-1(P.P.), PWD, Kanpur Nagar", after completion of tendering process or opening of technical and financial bid. In case the bidder is not provided the above original documents then the legal action should be taken along with the Cancellation of registration and blacklisting of the firm/contractor.
7. Bids must be submitted online (uploaded) on or before 12:00 NOON on dated 26.05.2026 and the technical bids will be opened online on the Same working day, that is, on dated 26.05.2026 at 12.30 pm. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day respectively, at the same time and validity of bid will be considered from the original date. The date and time of opening of the financial bid shall be notified on website. The Financial bids shall be accordingly opened online.
8. A pre-bid meeting shall be held in the Office of the Executive Engineer, CD-1(P.P), P.W.D., Kanpur Nagar for each work on dated 23.05.2026 at 12.00 Noon corresponding to the respective package to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of 'Instructions to Bidders' of the bidding document.
9. A bidder must not have in his employment-
  - (i) The near relations (defined as first blood relations and their spouse of the bidder or the bidder's spouse) of persons listed in the Appendix to ITB.
  - (ii) Without Government permission any person who retired as gazetted officer within the last two years of rank and form the departments listed in the Appendix to ITB.
10. No Engineer of gazetted rank or other Gazetted Office employed in Engineering of Administrative duties in an Engineering Department of the State / Central Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the contractor or any his employees is found and time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the contractor's service.
11. Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can-be seen in the office of the Executive Engineer mentioned in column 7 of the table

corresponding to the respective package between hours of 11.00 am to 04.00 pm on any working day between 18.05.2026 to 26.05.2026.

12. Any bidder who is having criminal record is not allowed to participate in the bidding process.
13. Any bidder who is registered with the State Bar Council is not allowed to participate in the bidding process.
14. Each bidder is required to furnish an affidavit online on a non-judicial stamp paper of Rs. 100/- giving all information on prescribed Performa required for evaluation of the bidding capacity of the bidder.
15. Bidder must submit information/document on prescribed Performa i.e., T4, T5, T6 in original/ photocopy with each bid.
16. 1% Labour cess will be deducted from the Contractor Bill.
17. In PWD technical evaluation of tenders is to be done by Prahari Software. URL for Prahari is <http://wms.uppwd.gov.in/Prahari/>. On opening of the website Prahari login page will open in which user type Contractor is to be selected User name and password for login on Prahari shall be same as used for contractor's registration on Chanakya Portal Bidders have to upload all the basic information and required document on Prahari as given in Prahari in detail if a bidder does not upload information and document on Prahari technical evaluation of the tender shall not be done and the bidder will be responsible for that.
18. After uploading all the information & documents on Prahari bidders shall have to download technical sheet E1. after submitting Scan copy of technical sheet E1 shall be then uploaded on e-tender portal <http://etender.up.nic.in> by the bidder. Bidder shall not upload any document other than technical sheet E1 on e-tender portal. If the bidder is uploading any document other than technical sheet E1 on e-tender portal, the document uploaded on e-tender portal shall not be considered for technical evaluation and claim of contractor in this regard shall not be entertained.
19. Bidders are expected to upload all the informations and documents well before submission date and time to avoid problem caused by slow internet speed/problem related to Prahari, Any claim of contractor in this regard shall not be entertained after wards.
20. Some informations/documents to be uploaded by bidders on Prahari have to be approved by the department for final submission Bidders are advised to contact any Division/Circle of department after uploading on Prahari such informations/documents with original documents and ensure its approval from the authority of the department.
21. Additional security money will be payable according to GO No.: 692/23-07-2024 Dated 09-08-2024 for unbalanced bids.
22. As per direction of G.O. No. 3460/23-7-08-14M.S.A./54T.C.3 Dt. 28.07.2008 SC/ST Bidder Can Submit their Bid with 2% security money of estimated cost and rest security money will be deposited at the time of agreement of bond.
23. GST shall be applicable as per existing Government Policies and Rules.
24. Defect liability period as per rule 2 years.
25. In case of any dispute about above tender the jurisdiction of Honable district court, Kanpur nagar will be applicable.
26. Under the provisions contained in Government Order No.-14/2020/879 / twenty-three-2020-176 (S) / 06 dated 25.08.2020, the contractor selected "Prahari" in the Chanakya software and loaded all the records related to the tender It is mandatory to download the technical sheet E-1 from the "Prahari" and upload it on the e-tender.
