**Restorative repairs in Deepvihar Higher Secondary School Building at
Headland, Sada.**

1. Invitation:

E -Tenders are invited by Mormugao Port Authority (MPA), Mormugao, Goa-403804 through <https://eprocure.gov.in/eprocure/app> of NIC- CPP portal from the contractors fulfilling the following Minimum Eligibility Criteria in two cover bidding procedure for the work **“Restorative repairs in Deepvihar Higher Secondary School Building at Headland, Sada”**.

1.1. Interested eligible tenderers may obtain further information and inspect the tender documents at the e- procurement website <https://eprocure.gov.in/eprocure/app>. This website can also be accessed by clicking the link at MPA's website <https://mptgoa.gov.in>

1.2. The cost of tender documents **Rs. 2360/-**(Rupees Two thousand three hundred sixty only Non-refundable) to pay by NEFT, Exemption is applicable as per Govt. Guideline. The details of payment or certificate of exemption along with bid security declaration shall be uploaded with the technical bid of the e-tender.

1.3. The Tender is to be submitted under two cover system, the first cover containing technical information and second cover containing the price bid

2. Minimum Eligibility Criteria:

2.1.To qualify for the tender, the tenderer must satisfy the Financial and Technical eligibility criteria, as detailed in Table- below.

2.1 NOTE:

i) The bidder should have a Office registered in Goa. The bidder shall submit along with the tender document valid documentary proof of office address such as Certificate of incorporation OR - Registration Certificate OR - GST registration, or Registration with Village Panchayat or any Govt. organization in the State of Goa (Details to be included in Annexure-III and documentary proof to be uploaded).

ii)The tenderer firms who fulfils the above eligibility conditions must also have registration with statutory authorities like ESIC,EPF ,GST ,Income tax , labour officer also with any other statutory authorities which is found necessary in time to time and accordingly must

upload self-attested scanned copies of all supporting documents along with the tender, failing which their bids will be rejected

iii)The tenderer shall have completed the 'similar work/s' as 'Prime Contractor' or 'approved sub-contractor' with reference being submitted to confirm satisfactory performance from the employer.

iv) If the bidder executed the work in private organization then necessary TDS certificate issued by competent authority or form 26/A issued by IT department shall be uploaded.

v) **Partial completion /work in progress will not be considered for evaluation.**

vi)In order to cross verify the work experience claimed by the bidders, TDS certificate from their previous employers shall be submitted. In case of difficulty on submission of TDS, Form 26AS of IT Department shall be submitted.

vii).Joint venture /Consortium not allowed for this Tender.

viii)The tenderer shall furnish complete information in respect of their firm, including financial and technical capabilities etc. in **Annexure-IV', Annexure-V' & Annexure -VI'** enclosed with the Tender and shall upload: .

a)The Self-attested photo copies of Annual average Financial Turnover statement /Certificate as at **Annexure-V** for the years (2022-23, 2023-24 & 2024-25) along with Balance sheets/Profit & loss account statements duly signed by chartered Accountant with UDIN Number in support of fulfilling Financial eligibility criteria ..

b)The Self-attested photo copies of LOA/work order/Agreements showing the awarded contract value for "similar works" and satisfactory Completion Certificates issued by the Client (duly signed and stamped), indicating the reference of LOA/work order/Agreements, value of work order, date of commencement of work, actual date of Completion of works, actual completed Contract Value from client, for the contracts mentioned at **Annexure-VI.**

c) In case the bidder fails to fill Annexure-VI (List of completed similar works), the documents uploaded by the bidder such as copies of the work orders, completion certificates, BOQ's, etc. shall be considered for evaluation.

ix)The bidder must upload self-attested scanned copies of all the above relevant documents pertaining to MEC along with the tender . It is not mandatory for the bidder to sign and stamp each page of the tender while uploading, **However, it is mandatory for the bidder to upload all the Annexures duly filled, signed and stamped, failing which their bids will be treated as Non Responsive and will not be considered for further evaluation .**

x)The tenderers will be short-listed based on the Eligibility criteria detailed in Clause Nos. 2.1(A), 2(B) & (C) above. The Second Cover of the short-listed tenderers will be opened on the date and time, which will be intimated to them subsequently.

2.2 The employer shall consider the bids which have been determined to be eligible and responsive to the bid documents and may award contract to one single bidder. It shall be expressly understood here that the decision of the employer in this regard shall be final and binding on the bidder.

2.3.The bidder firm should not have been indicted for any criminal, fraudulent or anti-competition activity and not been blacklisted by any Govt. departments. Bidder to submit a undertaking in **Annexure -II.**

2.4. The tenderer shall furnish all the details as per the NIOT. The Port will not obtain any further clarification after opening of the technical bid. Conditional and incomplete submission of tender liable to be treated as non-responsive and shall be rejected.

2.5. Even though the Bidders meet the qualifying criteria as per clause 2, they are subject to be disqualified and debarred for a period of three (3) years from participating for tenders at Mormugao Port Authority duly informing the MSME authorities if applicable, if they have :

a) Made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and

b) Having record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history with Mormugao Port Authority or financial failures etc.

2.6. Conditional Tender will be rejected outright considering it as nonresponsive offer and tender will be liable to be rejected outright if it is found that;

i) The Tenderer proposes any alteration in the work specified in the tender or in time allowed for completing the works or indicate any other unacceptable condition.

ii) All corrections are not initialed by the tenderer.

iii) Disclosure/indication of the price in the technical bid shall render the tender disqualified and rejected.

iv) The bid is non-responsive

2.7. The Tender prepared by the tenderer, all documents and correspondence in respect of or in connection with the tender and the work to be executed hereunder shall be in English Language only.

2.8. The Tenderer shall examine carefully, all instructions, General Conditions of Contract, Specifications, Bill of quantities, Scope of work, Drawings etc. and all documents issued along with and for the purpose of tender, any amendments made there to from time to time and in general shall be deemed to have been examined and obtained all necessary information as to risks, contingencies and other circumstances which may influence or affect his tender. Failure to comply with the requirements of the tender documents will be on tenderers own risks. Tenders, who are not substantially responsive to the requirement of the tender documents, are liable to be rejected.

2.9. Tenderer shall bear all costs for preparation and submission of his tender. Employer will not be responsible for or pay for any expenses or losses, which might be incurred or suffered by any tenderer in connection with submission of tender.

2.10. At any time prior to the last date for submission of tenders, the employer may for any reason whatsoever change or modify the tender documents by amendments. The amendments so carried out will be hosted on e-procure & MPA website. The amendment so carried out will form part of the tender and shall be binding upon the Tenderers. The Employer may at their discretion extend the last date for submission of the tenders to enable the Tenderers reasonable time to submit their tender after taking into consideration such amendments. The responsibility of downloading such documents from above website fully lies with the Tenderer.

2.11 The employer shall consider the bids which have been determined to be eligible and

responsive to the bid documents and may award contract to one single bidder. It shall be expressly understood here that the decision of the employer in this regard shall be final and binding on the bidder.
